- TEST WITH ALTERNATIVE CABLES OR PORTS.
- PROTOCOL ERRORS
- CONFIRM PROTOCOL COMPATIBILITY WITH CONNECTED DEVICES.
- UPDATE FIRMWARE IF PROTOCOL SUPPORT HAS BEEN IMPROVED.

CHANNEL MALFUNCTIONS

- NO SIGNAL OUTPUT
- CHECK INPUT SIGNALS FOR CORRECTNESS.
- VERIFY OUTPUT WIRING AND LOAD CONDITIONS.
- INCORRECT SIGNAL READINGS
- CALIBRATE CHANNELS ACCORDING TO MANUAL INSTRUCTIONS.
- INSPECT FOR DAMAGED COMPONENTS OR CONNECTIONS.

OVERTEMPERATURE OR SAFETY ALERTS

- ENSURE ADEQUATE VENTILATION.
