THE EXAM ENSURES THAT INDIVIDUALS RESPONSIBLE FOR LICENSED CHILD CARE FACILITIES POSSESS THE NECESSARY KNOWLEDGE TO PROMOTE A SAFE, NURTURING, AND COMPLIANT ENVIRONMENT FOR CHILDREN.

WHO NEEDS TO TAKE THE EXAM?

- CONFIRM THAT ALL QUESTIONS ARE ANSWERED BEFORE SUBMITTING.

POST-EXAM STEPS AND CERTIFICATION
