GENERAL SECURITY PATROL CERTIFICATE

SCHOOL SAFETY PATROL CERTIFICATE

DESIGNED FOR STUDENT VOLUNTEERS OR STAFF RESPONSIBLE FOR MAINTAINING SAFETY AROUND EDUCATIONAL INSTITUTIONS.

SPECIALIZED PATROL CERTIFICATES

FOR SPECIFIC ROLES SUCH AS MOBILE PATROL, CORPORATE SECURITY, OR EVENT SECURITY.

HOW TO OBTAIN A SAFETY PATROL CERTIFICATE

ACQUIRING A SAFETY PATROL CERTIFICATE TYPICALLY INVOLVES SEVERAL STEPS:

Early major developments determined the town's future: moving the county seat from Port Madison to Sidney, renaming the town Port Orchard, and locating the Washington State Veterans Home near Port Orchard.
