- "CHANGES IN SLEEP" – DIFFICULTY SLEEPING OR OVERSLEEPING.

THE RESPONDENT SELECTS THE STATEMENT THAT BEST DESCRIBES THEIR EXPERIENCE OVER THE PAST TWO WEEKS.

SCORING AND INTERPRETATION

THE TOTAL SCORE RANGES FROM 0 TO 63, WITH HIGHER SCORES INDICATING MORE SEVERE DEPRESSION. THE COMMONLY USED INTERPRETATION GUIDELINES ARE:

- 0–13: MINIMAL DEPRESSION
- 14–19: MILD DEPRESSION
- 20–28: MODERATE DEPRESSION
- 29–63: SEVERE DEPRESSION

CLINICIANS USE THESE SCORES TO DETERMINE THE NEED FOR INTERVENTION AND TO TAILOR TREATMENT APPROACHES.

WEEKS, INCLUDING THE DAY OF ASSESSMENT.

SAMPLE ITEMS INCLUDE:

- SADNESS: "PLEASE CHOOSE THE STATEMENT THAT BEST DESCRIBES HOW YOU HAVE BEEN FEELING DURING THE PAST TWO WEEKS."
- LOSS OF PLEASURE: "I DON'T ENJOY THINGS THE WAY I USED TO."
- SELF-CRITICISM: "I FEEL LIKE A FAILURE."

THE RESPONSES ARE SCORED ON A 4-POINT SCALE, RANGING FROM 0 (SYMPTOM ABSENT) TO 3 (SEVERE SYMPTOM).

SCORING AND INTERPRETATION

- TOTAL SCORES: SUMMING THE RESPONSES YIELDS A SCORE BETWEEN 0 AND 63.
- SEVERITY CATEGORIES:
 - 0-13: MINIMAL DEPRESSION
 - 14-19: MILD DEPRESSION
 - 20-28: MODERATE DEPRESSION
 - 29-63: SEVERE DEPRESSION

THESE CATEGORIES ASSIST CLINICIANS IN DETERMINING THE LEVEL OF INTERVENTION REQUIRED AND TRACKING CHANGES OVER TIME.

PRACTICAL APPLICATIONS OF THE BDI-II PDF IN CLINICAL SETTINGS

SCREENING AND DIAGNOSIS
