NCOER SUPPORT FORM EXAMPLES ARE ESSENTIAL RESOURCES FOR MILITARY PERSONNEL SEEKING TO UNDERSTAND HOW TO EFFECTIVELY DOCUMENT AND EVALUATE SUBORDINATE PERFORMANCE ON THE NON-COMMISSIONED OFFICER EVALUATION REPORT (NCOER). THESE EXAMPLES SERVE AS PRACTICAL GUIDES, DEMONSTRATING THE APPROPRIATE LANGUAGE, STRUCTURE, AND CONTENT TO ACCURATELY REFLECT A SOLDIER'S ACHIEVEMENTS, LEADERSHIP QUALITIES, AND POTENTIAL FOR FUTURE SERVICE. WHETHER YOU'RE A FIRST-TIME RATER OR A SEASONED COMMANDER, REVIEWING WELL-CRAFTED NCOER SUPPORT FORM EXAMPLES CAN ENHANCE THE QUALITY OF YOUR EVALUATIONS, ENSURING THEY ARE FAIR, COMPREHENSIVE, AND ALIGNED WITH ARMY STANDARDS. IN THIS ARTICLE, WE WILL EXPLORE VARIOUS NCOER SUPPORT FORM EXAMPLES TAILORED FOR DIFFERENT RANKS AND SCENARIOS, PROVIDING INSIGHTS INTO HOW TO DEVELOP IMPACTFUL SUPPORTING STATEMENTS THAT BOLSTER THE OVERALL EVALUATION.

UNDERSTANDING THE IMPORTANCE OF NCOER SUPPORT FORM EXAMPLES

BEFORE DIVING INTO SPECIFIC EXAMPLES, IT'S IMPORTANT TO RECOGNIZE WHY NCOER SUPPORT FORMS ARE CRITICAL IN THE EVALUATION PROCESS.

WHY SUPPORT STATEMENTS MATTER

SUPPORT STATEMENTS ARE THE NARRATIVE PORTION OF THE NCOER THAT JUSTIFY THE RATINGS ASSIGNED IN AREAS SUCH AS LEADERSHIP, DUTY PERFORMANCE, AND POTENTIAL. WELL-WRITTEN SUPPORT STATEMENTS CAN:

- HIGHLIGHT SPECIFIC ACCOMPLISHMENTS AND CONTRIBUTIONS
- PROVIDE CONTEXT FOR RATING DECISIONS
- HELP SOLDIERS PROGRESS IN THEIR CAREERS WITH STRONG RECOMMENDATIONS
- ENSURE CONSISTENCY AND FAIRNESS IN EVALUATIONS ACROSS DIFFERENT UNITS

THE ROLE OF EXAMPLES IN CRAFTING EFFECTIVE SUPPORT STATEMENTS

USING CONCRETE EXAMPLES AS A GUIDE HELPS RATERS ARTICULATE PRECISE, IMPACTFUL STATEMENTS. SUPPORT FORM EXAMPLES SERVE AS TEMPLATES THAT CAN BE ADAPTED TO INDIVIDUAL CIRCUMSTANCES, ENSURING CLARITY AND PROFESSIONALISM IN DOCUMENTATION.

COMMON NCOER SUPPORT FORM EXAMPLES BY RANK

DIFFERENT RANKS REQUIRE TAILORED SUPPORT STATEMENTS THAT REFLECT THE SCOPE OF RESPONSIBILITIES, LEADERSHIP CAPACITY, AND EXPERIENCE LEVEL. BELOW ARE EXAMPLES CATEGORIZED BY RANK, ILLUSTRATING HOW TO CRAFT COMPELLING SUPPORT NARRATIVES.

SERGEANT (E-5) SUPPORT FORM EXAMPLES

FOR SERGEANTS, SUPPORT STATEMENTS SHOULD FOCUS ON LEADERSHIP AT THE SQUAD OR TEAM LEVEL, TECHNICAL PROFICIENCY, AND INITIATIVE.

- **EXAMPLE 1:** "SGT. SMITH DEMONSTRATED EXCEPTIONAL LEADERSHIP BY MENTORING 12 SOLDIERS IN THE SUCCESSFUL

COMPLETION OF A 10-MILE RUCK MARCH, RESULTING IN A 100% PASS RATE. HIS PROACTIVE APPROACH TO TRAINING INCREASED SQUAD READINESS AND MORALE."

- **EXAMPLE 2:** "DISPLAYED TECHNICAL EXPERTISE IN WEAPONS MAINTENANCE, ENSURING ALL ASSIGNED EQUIPMENT WAS FULLY OPERATIONAL, WHICH DIRECTLY CONTRIBUTED TO THE COMPANY'S MISSION SUCCESS DURING THE RECENT FIELD EXERCISE."

SERGEANT FIRST CLASS (E-7) SUPPORT FORM EXAMPLES

AT THIS LEVEL, SUPPORT STATEMENTS SHOULD EMPHASIZE LEADERSHIP DEVELOPMENT, OPERATIONAL PLANNING, AND MENTORSHIP.

- **EXAMPLE 1:** "SFC JOHNSON EFFECTIVELY SUPERVISED A PLATOON OF 40 SOLDIERS, COORDINATING TRAINING SCHEDULES THAT IMPROVED OVERALL READINESS BY 25%. HIS MENTORSHIP FOSTERED A COHESIVE TEAM ENVIRONMENT, REDUCING TURNOVER."
- **EXAMPLE 2:** "LED A CRITICAL LOGISTICS OPERATION THAT DELIVERED SUPPLIES TO REMOTE OUTPOSTS AHEAD OF SCHEDULE, DEMONSTRATING SUPERIOR ORGANIZATIONAL SKILLS AND INITIATIVE."

MASTER SERGEANT (E-8) SUPPORT FORM EXAMPLES

SUPPORT STATEMENTS FOR E-8S SHOULD HIGHLIGHT STRATEGIC LEADERSHIP, PROGRAM MANAGEMENT, AND IMPACT ON UNIT COHESION.

- **EXAMPLE 1:** "MASTER SGT. LEE IMPLEMENTED A NEW SAFETY PROTOCOL ACROSS THE BATTALION, REDUCING ACCIDENTS BY 15%. HIS VISION AND LEADERSHIP IMPROVED OPERATIONAL SAFETY AND EFFICIENCY."
- **EXAMPLE 2:** "SERVED AS THE BATTALION'S SENIOR ENLISTED ADVISOR, PROVIDING GUIDANCE ON PERSONNEL ISSUES THAT ENHANCED SOLDIER DEVELOPMENT PROGRAMS AND FOSTERED A POSITIVE COMMAND CLIMATE."

CRAFTING EFFECTIVE SUPPORT STATEMENTS: TIPS AND BEST PRACTICES

DEVELOPING IMPACTFUL SUPPORT STATEMENTS REQUIRES ATTENTION TO DETAIL AND ADHERENCE TO ARMY EVALUATION STANDARDS. HERE ARE SOME TIPS TO ENHANCE YOUR WRITING.

USE ACTION-ORIENTED LANGUAGE

START SENTENCES WITH STRONG ACTION VERBS SUCH AS "LED," "DEVELOPED," "IMPLEMENTED," "MENTORED," AND "IMPROVED" TO CONVEY ACTIVE CONTRIBUTION.

BE SPECIFIC AND QUANTIFY ACHIEVEMENTS

WHENEVER POSSIBLE, INCLUDE MEASURABLE OUTCOMES OR SPECIFIC EXAMPLES. FOR INSTANCE:

- INCREASED UNIT TRAINING COMPLETION RATE FROM 80% TO 95%

- LED A TEAM THAT COMPLETED A \$2 MILLION PROJECT UNDER BUDGET AND AHEAD OF SCHEDULE

FOCUS ON LEADERSHIP AND IMPACT

HIGHLIGHT HOW THE SOLDIER'S ACTIONS INFLUENCED THE UNIT, IMPROVED PROCESSES, OR CONTRIBUTED TO MISSION SUCCESS.

AVOID VAGUE LANGUAGE

STEER CLEAR OF GENERIC PHRASES LIKE "DONE WELL" OR "PERFORMED DUTIES SATISFACTORILY." INSTEAD, PROVIDE DETAILED ACCOUNTS OF WHAT WAS ACHIEVED.

SAMPLE NCOER SUPPORT FORM STATEMENTS FOR DIFFERENT SCENARIOS

TO FURTHER ASSIST, HERE ARE TAILORED SUPPORT EXAMPLES FOR COMMON SITUATIONS.

FOR EXCEPTIONAL PERFORMANCE

- "SGT. DOE CONSISTENTLY EXCEEDS STANDARDS BY DEVELOPING INNOVATIVE TRAINING METHODS THAT INCREASED SQUAD PROFICIENCY SCORES FROM 85% TO 98%. HIS DEDICATION DIRECTLY CONTRIBUTED TO THE UNIT'S READINESS FOR DEPLOYMENT."

FOR LEADERSHIP DEVELOPMENT

- "SGT. FIRST CLASS MARTINEZ HAS EFFECTIVELY MENTORED 15 JUNIOR SOLDIERS, MANY OF WHOM RECEIVED AWARDS AND PROMOTIONS. HIS LEADERSHIP HAS CULTIVATED A HIGHLY MOTIVATED AND DISCIPLINED TEAM."

FOR TECHNICAL EXPERTISE

- "MASTER SGT. NGUYEN'S EXPERTISE IN COMMUNICATIONS SYSTEMS ENSURED UNINTERRUPTED OPERATIONS DURING A CRITICAL MISSION, MINIMIZING DOWNTIME AND MAINTAINING BATTLEFIELD CONNECTIVITY."

FOR AREAS NEEDING IMPROVEMENT

WHILE SUPPORT STATEMENTS SHOULD GENERALLY FOCUS ON STRENGTHS, CONSTRUCTIVE FEEDBACK CAN BE INCLUDED TACTFULLY.

- "WHILE SGT. LEE DEMONSTRATES STRONG TECHNICAL SKILLS, ADDITIONAL FOCUS ON TIME MANAGEMENT WILL FURTHER ENHANCE HIS ABILITY TO MEET TIGHT DEADLINES."

CONCLUSION

EFFECTIVE NCOER SUPPORT FORM EXAMPLES ARE INVALUABLE TOOLS FOR RECOGNIZING AND DOCUMENTING A SOLDIER'S CONTRIBUTIONS ACCURATELY. THEY HELP ENSURE EVALUATIONS ARE COMPREHENSIVE, FAIR, AND IMPACTFUL, ULTIMATELY AIDING IN CAREER PROGRESSION AND PROFESSIONAL DEVELOPMENT. BY STUDYING WELL-CRAFTED EXAMPLES AT VARIOUS RANKS AND SCENARIOS, RATERS CAN DEVELOP THEIR OWN SUPPORT STATEMENTS THAT TRULY REFLECT A SOLDIER'S PERFORMANCE. REMEMBER TO USE ACTION-ORIENTED, SPECIFIC LANGUAGE, AND FOCUS ON TANGIBLE IMPACTS TO CREATE COMPELLING NARRATIVES THAT SUPPORT YOUR RATINGS. WHETHER YOU ARE PREPARING AN NCOER FOR A NEWLY PROMOTED SERGEANT OR A SEASONED MASTER SERGEANT, LEVERAGING THESE EXAMPLES CAN SIGNIFICANTLY ENHANCE THE QUALITY AND CREDIBILITY OF YOUR EVALUATIONS.

BY CONTINUOUSLY REFINING YOUR WRITING SKILLS AND UTILIZING EXEMPLARY SUPPORT FORM EXAMPLES, YOU CONTRIBUTE TO A FAIR AND EFFECTIVE EVALUATION SYSTEM THAT RECOGNIZES EXCELLENCE AND ENCOURAGES GROWTH WITHIN THE ARMY.

FREQUENTLY ASKED QUESTIONS

WHAT IS AN NCOER SUPPORT FORM EXAMPLE?

AN NCOER SUPPORT FORM EXAMPLE IS A SAMPLE OR TEMPLATE THAT ILLUSTRATES HOW TO PROPERLY COMPLETE THE NON-COMMISSIONED OFFICER EVALUATION REPORT SUPPORT FORM, ENSURING ACCURACY AND CONSISTENCY IN EVALUATIONS.

WHERE CAN I FIND RELIABLE NCOER SUPPORT FORM EXAMPLES ONLINE?

RELIABLE NCOER SUPPORT FORM EXAMPLES CAN TYPICALLY BE FOUND ON OFFICIAL ARMY WEBSITES, TRAINING MODULES, OR MILITARY PROFESSIONAL DEVELOPMENT PLATFORMS LIKE THE ARMY PUBLISHING DIRECTORATE OR ARMY LEARNING MANAGEMENT SYSTEM.

WHAT ARE KEY COMPONENTS INCLUDED IN AN NCOER SUPPORT FORM EXAMPLE?

KEY COMPONENTS INCLUDE THE NCO'S PERSONAL INFORMATION, DUTY DESCRIPTION, PERFORMANCE OBJECTIVES, ACHIEVEMENTS, LEADERSHIP ATTRIBUTES, AND OVERALL EVALUATION RATINGS, ALL DEMONSTRATED IN THE SAMPLE SUPPORT FORM.

HOW CAN I CUSTOMIZE AN NCOER SUPPORT FORM EXAMPLE FOR MY SPECIFIC ROLE?

YOU CAN CUSTOMIZE AN EXAMPLE BY ADJUSTING THE DUTY DESCRIPTIONS, PERFORMANCE HIGHLIGHTS, AND LEADERSHIP EXAMPLES TO REFLECT YOUR ACTUAL RESPONSIBILITIES AND ACCOMPLISHMENTS WHILE MAINTAINING THE PROPER FORMAT.

ARE THERE ANY COMMON MISTAKES TO AVOID IN NCOER SUPPORT FORM EXAMPLES?

COMMON MISTAKES INCLUDE VAGUE DESCRIPTIONS, LACK OF MEASURABLE ACHIEVEMENTS, INCORRECT FORMATTING, AND FAILING TO ALIGN THE SUPPORT FORM WITH THE EVALUATION CRITERIA. REVIEWING OFFICIAL GUIDELINES HELPS PREVENT THESE ERRORS.

HOW DO NCOER SUPPORT FORM EXAMPLES ASSIST IN PREPARING FOR EVALUATION PERIODS?

THEY SERVE AS A REFERENCE TO UNDERSTAND PROPER DOCUMENTATION, ENSURE ALL CRITICAL AREAS ARE ADDRESSED, AND HELP NCOs PREPARE COMPREHENSIVE AND ACCURATE SUPPORT FORMS FOR THEIR EVALUATIONS.

CAN I FIND NCOER SUPPORT FORM EXAMPLES FOR DIFFERENT RANKS OR SPECIALTIES?

YES, EXAMPLES ARE OFTEN TAILORED FOR VARIOUS RANKS AND SPECIALTIES, AVAILABLE THROUGH OFFICIAL MILITARY RESOURCES OR TRAINING COURSES TO ENSURE RELEVANCE TO SPECIFIC ROLES.

WHAT IS THE IMPORTANCE OF USING ACCURATE NCOER SUPPORT FORM EXAMPLES?

USING ACCURATE EXAMPLES ENSURES FAIR AND CONSISTENT EVALUATIONS, HELPS HIGHLIGHT THE NCO'S STRENGTHS EFFECTIVELY, AND AIDS IN PROFESSIONAL DEVELOPMENT AND CAREER PROGRESSION.

ARE THERE ANY TOOLS OR SOFTWARE TO HELP CREATE NCOER SUPPORT FORMS BASED ON EXAMPLES?

YES, MILITARY-SPECIFIC EVALUATION TOOLS AND TEMPLATES ARE AVAILABLE THAT STREAMLINE THE PROCESS OF CREATING NCOER SUPPORT FORMS, OFTEN INTEGRATED INTO MILITARY PERSONNEL MANAGEMENT SYSTEMS OR AVAILABLE AS DOWNLOADABLE TEMPLATES.

ADDITIONAL RESOURCES

NCOER SUPPORT FORM EXAMPLES: AN IN-DEPTH GUIDE FOR MILITARY LEADERS AND SUPPORT PERSONNEL

THE NON-COMMISSIONED OFFICER EVALUATION REPORT (NCOER) IS A PIVOTAL DOCUMENT WITHIN THE U.S. ARMY'S PERSONNEL MANAGEMENT SYSTEM. IT SERVES AS A COMPREHENSIVE ASSESSMENT OF AN NCO'S PERFORMANCE, POTENTIAL, AND PROFESSIONAL DEVELOPMENT. THE NCOER SUPPORT FORM, OFTEN REFERRED TO AS THE "SUPPORTING DOCUMENTATION," PROVIDES ADDITIONAL CONTEXT, EVIDENCE, AND EXAMPLES THAT UNDERPIN THE RATINGS AND COMMENTS GIVEN IN THE MAIN EVALUATION REPORT. FOR SOLDIERS, NCOs, AND SUPPORT STAFF, UNDERSTANDING THE NUANCES OF NCOER SUPPORT FORMS—PARTICULARLY THROUGH WELL-CRAFTED EXAMPLES—IS ESSENTIAL FOR ACCURATELY DOCUMENTING PERFORMANCE AND ENSURING FAIR EVALUATIONS.

THIS ARTICLE EXPLORES NCOER SUPPORT FORM EXAMPLES IN DETAIL, OFFERING INSIGHTS INTO THEIR STRUCTURE, PURPOSE, AND BEST PRACTICES. WE WILL ANALYZE TYPICAL CONTENT, PROVIDE SAMPLE ENTRIES, AND HIGHLIGHT COMMON PITFALLS TO AVOID. OUR GOAL IS TO SERVE AS A COMPREHENSIVE RESOURCE FOR MILITARY PERSONNEL INVOLVED IN THE EVALUATION PROCESS, WHETHER THEY ARE PREPARING SUPPORT FORMS FOR THEIR SUBORDINATES OR REVIEWING THEM FOR ACCURACY AND FAIRNESS.

UNDERSTANDING THE NCOER AND ITS SUPPORT FORM COMPONENTS

THE PURPOSE OF THE NCOER SUPPORT FORM

THE NCOER SUPPORT FORM FUNCTIONS AS AN ANNEX OR ADDENDUM THAT OFFERS CONCRETE EXAMPLES, EVIDENCE, AND DETAILED DESCRIPTIONS OF AN NCO'S PERFORMANCE. IT COMPLEMENTS THE NARRATIVE COMMENTS AND RATINGS IN THE MAIN REPORT BY:

- PROVIDING SPECIFIC INSTANCES OF LEADERSHIP, TECHNICAL PROFICIENCY, AND PROFESSIONALISM.
- DEMONSTRATING THE IMPACT OF THE NCO'S ACTIONS ON UNIT READINESS, MORALE, AND MISSION SUCCESS.
- OFFERING MEASURABLE RESULTS OR QUALITATIVE OBSERVATIONS THAT STRENGTHEN THE EVALUATION.

EFFECTIVE SUPPORT FORMS HELP EVALUATORS JUSTIFY RATINGS AND PROVIDE CLEAR, OBJECTIVE EVIDENCE TO SUPPORT THE SUMMARY STATEMENTS. CONVERSELY, POORLY CONSTRUCTED SUPPORT ENTRIES CAN UNDERMINE THE CREDIBILITY OF THE ENTIRE EVALUATION.

KEY ELEMENTS OF AN EFFECTIVE NCOER SUPPORT FORM

SUCCESSFUL SUPPORT FORMS ARE CHARACTERIZED BY CLARITY, SPECIFICITY, RELEVANCE, AND PROFESSIONALISM. THEY TYPICALLY INCLUDE:

- CONTEXT: BRIEF BACKGROUND OR SITUATION.
- ACTION: SPECIFIC BEHAVIORS, INITIATIVES, OR LEADERSHIP ACTIONS TAKEN.
- RESULT/IMPACT: QUANTIFIABLE OR QUALITATIVE OUTCOMES THAT DEMONSTRATE EFFECTIVENESS.
- SUPPORTING EVIDENCE: DATA, TESTIMONIES, OR DOCUMENTATION THAT SUBSTANTIATE CLAIMS.

BELOW, WE EXPLORE EACH ELEMENT IN DETAIL WITH EXAMPLES.

SAMPLE NCOER SUPPORT FORM ENTRIES BY CATEGORY

TO ILLUSTRATE BEST PRACTICES, THE FOLLOWING SECTIONS PROVIDE SAMPLE ENTRIES TAILORED TO COMMON NCO COMPETENCIES: LEADERSHIP, TECHNICAL PROFICIENCY, TRAINING, SOLDIER DEVELOPMENT, AND COMMUNITY INVOLVEMENT.

LEADERSHIP AND SUPERVISION

EXAMPLE 1: LEADING A CRITICAL PROJECT

CONTEXT: TASKED WITH OVERSEEING THE INSTALLATION OF NEW COMMUNICATION EQUIPMENT IN A DEPLOYED ENVIRONMENT.

SUPPORT ENTRY:

> "SGT. JOHNSON LED A TEAM OF FIVE SOLDIERS DURING THE DEPLOYMENT OF A COMPLEX COMMUNICATION SYSTEM, ENSURING 100% OPERATIONAL READINESS WITHIN 48 HOURS—50 HOURS AHEAD OF SCHEDULE. HIS PROACTIVE PLANNING AND CLEAR DELEGATION REDUCED POTENTIAL DELAYS, DIRECTLY ENHANCING MISSION COMMAND CAPABILITIES. RECEIVED COMMENDATION FROM THE COMMANDING OFFICER FOR EXCEPTIONAL OPERATIONAL LEADERSHIP."

EXAMPLE 2: MENTORING SUBORDINATES

CONTEXT: DEVELOPING JUNIOR NCOs AND SOLDIERS.

SUPPORT ENTRY:

> "SGT. LEE MENTORED TWO JUNIOR NCOs, FACILITATING THEIR SUCCESSFUL COMPLETION OF ADVANCED LEADERSHIP COURSES. HIS GUIDANCE CONTRIBUTED TO A 20% INCREASE IN SOLDIER PROMOTION RATES WITHIN HIS SQUAD, FOSTERING A CULTURE OF CONTINUOUS PROFESSIONAL DEVELOPMENT."

TECHNICAL PROFICIENCY AND JOB PERFORMANCE

EXAMPLE 1: MAINTENANCE EXPERTISE

CONTEXT: MAINTAINING HEAVY EQUIPMENT UNDER DEMANDING CONDITIONS.

SUPPORT ENTRY:

> "SGT. RAMIREZ PERFORMED ROUTINE AND EMERGENCY REPAIRS ON M1 ABRAMS TANKS, REDUCING BREAKDOWN INCIDENTS BY

30%. His technical mastery minimized downtime and maintained operational tempo during combat operations."

EXAMPLE 2: SAFETY COMPLIANCE

CONTEXT: ENSURING SAFETY STANDARDS DURING TRAINING EXERCISES.

SUPPORT ENTRY:

> "SGT. PATEL RIGOROUSLY ENFORCED SAFETY PROTOCOLS DURING LIVE-FIRE DRILLS, RESULTING IN ZERO ACCIDENTS OVER A THREE-MONTH PERIOD. HIS VIGILANT SUPERVISION ENHANCED UNIT SAFETY AND SET A STANDARD FOR BEST PRACTICES."

TRAINING AND DEVELOPMENT

EXAMPLE 1: CONDUCTING TRAINING SESSIONS

CONTEXT: LEADING A TACTICAL COMBAT CASUALTY CARE (TCCC) COURSE.

SUPPORT ENTRY:

> "SGT. WILLIAMS DEVELOPED AND DELIVERED A COMPREHENSIVE TCCC TRAINING SESSION FOR 40 SOLDIERS, INCREASING THEIR FIRST AID PROFICIENCY FROM 60% TO 95%. HIS INNOVATIVE INSTRUCTIONAL TECHNIQUES RECEIVED HIGH PRAISE FROM TRAINEES."

EXAMPLE 2: CURRICULUM IMPROVEMENT

CONTEXT: UPDATING UNIT TRAINING MATERIALS.

SUPPORT ENTRY:

> "SGT. NGUYEN REVAMPED THE UNIT'S MARKSMANSHIP TRAINING CURRICULUM, INCORPORATING INTERACTIVE MODULES THAT IMPROVED QUALIFICATION SCORES BY AN AVERAGE OF 15%. HER INITIATIVE ENHANCED OVERALL COMBAT READINESS."

SOLDIER DEVELOPMENT AND MENTORSHIP

EXAMPLE 1: CAREER COUNSELING

CONTEXT: ASSISTING SOLDIERS WITH CAREER PROGRESSION.

SUPPORT ENTRY:

> "SGT. MARTINEZ PROVIDED INDIVIDUALIZED COUNSELING SESSIONS, GUIDING THREE SOLDIERS THROUGH REENLISTMENT AND PROFESSIONAL DEVELOPMENT OPTIONS, RESULTING IN ALL THREE REENLISTING AND PURSUING LEADERSHIP COURSES."

EXAMPLE 2: RECOGNIZING AND ADDRESSING PERFORMANCE ISSUES

CONTEXT: SUPPORTING A STRUGGLING SOLDIER.

SUPPORT ENTRY:

> "SGT. CHEN IDENTIFIED PERFORMANCE GAPS IN PVT. SMITH, PROVIDING TARGETED MENTORSHIP AND ADDITIONAL TRAINING. AS A RESULT, PVT. SMITH ACHIEVED A 20-POINT INCREASE IN PHYSICAL FITNESS SCORES AND IMPROVED OVERALL PERFORMANCE."

COMMUNITY AND MORALE INITIATIVES

EXAMPLE 1: COMMUNITY SERVICE

CONTEXT: ORGANIZING UNIT PARTICIPATION IN LOCAL CHARITY EVENTS.

SUPPORT ENTRY:

> "SGT. DAVIS COORDINATED A UNIT VOLUNTEER EFFORT AT THE LOCAL FOOD BANK, COLLECTING OVER 500 POUNDS OF FOOD AND BOOSTING COMMUNITY RELATIONS. HIS LEADERSHIP FOSTERED UNIT COHESION AND COMMUNITY SUPPORT."

EXAMPLE 2: MORALE BUILDING

CONTEXT: ENHANCING UNIT MORALE DURING DEPLOYMENT.

SUPPORT ENTRY:

> "SGT. RODRIGUEZ ORGANIZED WEEKLY MORALE EVENTS, INCLUDING MOVIE NIGHTS AND FAMILY GATHERINGS, SIGNIFICANTLY IMPROVING SOLDIER WELFARE AND COHESION DURING PROLONGED DEPLOYMENT."

BEST PRACTICES FOR WRITING NCOER SUPPORT FORMS

CREATING IMPACTFUL SUPPORT ENTRIES REQUIRES ATTENTION TO DETAIL AND ADHERENCE TO STANDARDS. CONSIDER THE FOLLOWING BEST PRACTICES:

- BE SPECIFIC AND OBJECTIVE: USE CONCRETE EXAMPLES WITH MEASURABLE OUTCOMES WHENEVER POSSIBLE.
- USE ACTION-ORIENTED LANGUAGE: BEGIN DESCRIPTIONS WITH ACTION VERBS SUCH AS "LED," "DEVELOPED," "IMPLEMENTED," OR "MENTORED."
- QUANTIFY RESULTS: INCLUDE DATA OR STATISTICS TO ILLUSTRATE IMPACT (E.G., "% INCREASE," "REDUCED DOWNTIME BY X HOURS").
- MAINTAIN PROFESSIONAL TONE: USE PROPER GRAMMAR, AVOID SLANG, AND FOCUS ON FACTS.
- ALIGN WITH RATED DUTIES: ENSURE SUPPORT ENTRIES ARE RELEVANT TO THE NCO'S ROLE AND RESPONSIBILITIES.
- AVOID REDUNDANCY: PROVIDE FRESH EXAMPLES ACROSS DIFFERENT CATEGORIES RATHER THAN REPEATING SIMILAR STATEMENTS.

COMMON PITFALLS AND HOW TO AVOID THEM

WHILE CRAFTING SUPPORT FORMS, EVALUATORS AND WRITERS SHOULD BE WARY OF CERTAIN PITFALLS:

- VAGUE LANGUAGE: PHRASES LIKE "GOOD LEADER" OR "HARD WORKER" LACK SPECIFICITY. INSTEAD, SPECIFY ACTIONS AND RESULTS.
- OVERLY GENERAL STATEMENTS: AVOID GENERIC COMMENTS THAT COULD APPLY TO ANYONE; TAILOR SUPPORT TO THE INDIVIDUAL'S ACHIEVEMENTS.
- BIAS OR PERSONAL OPINIONS: FOCUS ON PERFORMANCE-RELATED EVIDENCE RATHER THAN PERSONAL JUDGMENTS OR FAVORITISM.
- LACK OF SUPPORTING EVIDENCE: SUPPORT ENTRIES WITHOUT TANGIBLE EXAMPLES WEAKEN THE CREDIBILITY OF THE EVALUATION.
- IGNORING CONFIDENTIALITY AND PRIVACY: AVOID SHARING SENSITIVE INFORMATION OR CONFIDENTIAL DATA.

CONCLUSION: THE VALUE OF WELL-CRAFTED SUPPORT FORMS

THE IMPORTANCE OF NCOER SUPPORT FORM EXAMPLES CANNOT BE OVERSTATED. THESE ENTRIES SERVE AS THE BACKBONE OF A CREDIBLE, FAIR, AND COMPREHENSIVE EVALUATION. THEY PROVIDE CONCRETE EVIDENCE TO JUSTIFY RATINGS, INFLUENCE CAREER PROGRESSION, AND ENSURE DESERVING SOLDIERS RECEIVE RECOGNITION FOR THEIR EFFORTS.

FOR EVALUATORS AND SOLDIERS ALIKE, INVESTING TIME IN DEVELOPING DETAILED, OBJECTIVE, AND IMPACTFUL SUPPORT ENTRIES PAYS DIVIDENDS IN THE INTEGRITY OF THE EVALUATION PROCESS. BY UNDERSTANDING WHAT CONSTITUTES EFFECTIVE SUPPORT DOCUMENTATION—THROUGH EXAMPLES AND BEST PRACTICES—MILITARY PERSONNEL CAN ENHANCE THE QUALITY OF THEIR ASSESSMENTS, PROMOTE A CULTURE OF PROFESSIONALISM, AND SUPPORT THE PROFESSIONAL DEVELOPMENT OF NCOs AT EVERY LEVEL.

IN SUM, WHETHER YOU ARE PREPARING SUPPORT FORMS FOR YOUR TEAM OR REVIEWING EVALUATIONS, ALWAYS REMEMBER THAT CLARITY, SPECIFICITY, AND EVIDENCE-BASED DESCRIPTIONS ARE THE HALLMARKS OF A ROBUST NCOER SUPPORT DOCUMENT.
