- TRAVEL AGENCIES BOOKING ON BEHALF OF CLIENTS

 - DATE(S) OF SERVICE OR STAY

4. SIGNATURE AND DATE

- CARDHOLDER'S SIGNATURE
- DATE OF AUTHORIZATION

5. ADDITIONAL INFORMATION (IF APPLICABLE)

- COMPANY OR ORGANIZATION DETAILS
- PURCHASE ORDER NUMBER
- GUEST OR RESERVATION NUMBER

HOW TO FILL OUT A MARRIOTT CREDIT CARD AUTHORIZATION FORM

COMPLETING THE FORM ACCURATELY IS VITAL TO AVOID DELAYS OR ISSUES WITH BILLING. FOLLOW THESE STEP-BY-STEP INSTRUCTIONS:

STEP 1: GATHER NECESSARY INFORMATION

BEFORE FILLING OUT THE FORM, ENSURE YOU HAVE THE FOLLOWING:

FOR CONFERENCES OR WEDDINGS, WHERE MULTIPLE CHARGES MAY BE INVOLVED, THE FORM STREAMLINES BILLING.

4. RESERVATIONS WITHOUT A GUEST PRESENT

WHEN BOOKING IN ADVANCE OR FOR SOMEONE ELSE, ESPECIALLY IN CORPORATE TRAVEL ARRANGEMENTS.
