- NOTIFICATION FROM LICENSING AGENCIES

THE HOISTING LICENSE RENEWAL PROCESS

5. RECEIVING THE RENEWED LICENSE
 - UPON SUCCESSFUL REVIEW, THE AUTHORITY ISSUES A RENEWED LICENSE, OFTEN WITH AN UPDATED VALIDITY PERIOD

TIMELINE FOR RENEWAL

OPERATORS ARE ADVISED TO INITIATE RENEWAL AT LEAST 30-60 DAYS BEFORE LICENSE EXPIRY TO AVOID OPERATIONAL DISRUPTIONS. PROCESSING TIMES VARY BUT TYPICALLY RANGE FROM A FEW DAYS TO SEVERAL WEEKS DEPENDING ON JURISDICTION.

CHALLENGES AND COMMON PITFALLS IN HOISTING LICENSE RENEWAL
