MARYLAND STATE BOARD OF DENTAL EXAMINERS: ENSURING DENTAL PRACTICE STANDARDS AND PUBLIC SAFETY IN MARYLAND

THE **MARYLAND STATE BOARD OF DENTAL EXAMINERS** PLAYS A VITAL ROLE IN MAINTAINING HIGH STANDARDS WITHIN THE DENTAL PROFESSION IN MARYLAND. ITS PRIMARY MISSION IS TO PROTECT PUBLIC HEALTH BY REGULATING DENTAL PRACTITIONERS, ENSURING THEY MEET ESTABLISHED EDUCATIONAL AND ETHICAL STANDARDS, AND ENFORCING COMPLIANCE WITH STATE LAWS. WHETHER YOU ARE A DENTAL PROFESSIONAL SEEKING LICENSURE, A PATIENT LOOKING FOR QUALIFIED DENTAL CARE, OR AN INTERESTED STAKEHOLDER, UNDERSTANDING THE FUNCTIONS AND RESPONSIBILITIES OF THE MARYLAND STATE BOARD OF DENTAL EXAMINERS IS ESSENTIAL. OVERVIEW OF THE MARYLAND STATE BOARD OF DENTAL EXAMINERS

THE MARYLAND STATE BOARD OF DENTAL EXAMINERS OPERATES UNDER THE MARYLAND DEPARTMENT OF HEALTH AND MENTAL HYGIENE. IT IS COMPOSED OF LICENSED DENTAL PROFESSIONALS AND PUBLIC MEMBERS COMMITTED TO SAFEGUARDING PUBLIC HEALTH. THE BOARD'S MAIN OBJECTIVES INCLUDE REGULATING THE PRACTICE OF DENTISTRY, ISSUING LICENSES, ENFORCING LAWS AND REGULATIONS, AND PROMOTING ETHICAL CONDUCT AMONG DENTAL PRACTITIONERS.

MISSION AND VISION

- MISSION: TO PROTECT THE PUBLIC BY ENSURING THAT DENTAL PRACTITIONERS IN MARYLAND ARE QUALIFIED, COMPETENT, AND ADHERE TO PROFESSIONAL STANDARDS.
- VISION: TO FOSTER A SAFE, ETHICAL, AND PROFESSIONAL DENTAL COMMUNITY THROUGH EFFECTIVE REGULATION AND PUBLIC EDUCATION.

BOARD COMPOSITION AND STRUCTURE

THE BOARD TYPICALLY CONSISTS OF:

- LICENSED DENTISTS FROM VARIOUS SPECIALTIES
- DENTAL HYGIENISTS
- PUBLIC MEMBERS WITH NO PROFESSIONAL TIES TO DENTISTRY

MEMBERS ARE APPOINTED BY THE GOVERNOR AND SERVE FIXED TERMS, ENSURING DIVERSE REPRESENTATION AND BALANCED OVERSIGHT.

FUNCTIONS AND RESPONSIBILITIES OF THE MARYLAND STATE BOARD OF DENTAL EXAMINERS

THE BOARD'S CORE RESPONSIBILITIES ENCOMPASS REGULATION, LICENSING, ENFORCEMENT, AND PUBLIC OUTREACH. THESE FUNCTIONS ENSURE THE INTEGRITY AND SAFETY OF DENTAL PRACTICES WITHIN MARYLAND.

REGULATION OF DENTAL PRACTICE

THE BOARD ESTABLISHES AND ENFORCES RULES THAT GOVERN THE PRACTICE OF DENTISTRY AND DENTAL HYGIENE, INCLUDING:

- STANDARDS FOR CLINICAL PROCEDURES
- INFECTION CONTROL PROTOCOLS
- RECORDKEEPING REQUIREMENTS
- PATIENT RIGHTS AND CONFIDENTIALITY

LICENSING AND CERTIFICATION

THE BOARD ADMINISTERS LICENSING EXAMS AND ISSUES LICENSES TO QUALIFIED CANDIDATES. IT ALSO CERTIFIES DENTAL HYGIENISTS AND OTHER AUXILIARY PERSONNEL.

DISCIPLINARY ACTIONS AND ENFORCEMENT

THE MARYLAND STATE BOARD OF DENTAL EXAMINERS HOLDS THE AUTHORITY TO INVESTIGATE COMPLAINTS AND TAKE DISCIPLINARY ACTIONS AGAINST PRACTITIONERS WHO VIOLATE LAWS OR ETHICAL STANDARDS. THIS CAN INCLUDE:

- SUSPENSION OR REVOCATION OF LICENSES
- FINES
- PROBATION OR REPRIMANDS
- MANDATORY CONTINUING EDUCATION

PUBLIC EDUCATION AND OUTREACH

THE BOARD PROVIDES RESOURCES TO EDUCATE THE PUBLIC ABOUT DENTAL HEALTH AND HOW TO VERIFY THE CREDENTIALS OF DENTAL PROFESSIONALS.

LICENSING PROCESS IN MARYLAND

OBTAINING A DENTAL LICENSE IN MARYLAND INVOLVES RIGOROUS EDUCATION, EXAMINATION, AND BACKGROUND CHECKS TO ENSURE PRACTITIONERS ARE QUALIFIED TO SERVE THE PUBLIC.

EDUCATIONAL REQUIREMENTS

CANDIDATES MUST GRADUATE FROM AN ACCREDITED DENTAL SCHOOL OR EQUIVALENT PROGRAM APPROVED BY THE BOARD.

EXAMINATION REQUIREMENTS

APPLICANTS MUST PASS THE FOLLOWING EXAMS:

1. NATIONAL BOARD DENTAL EXAMINATION (NBDE)
2. CLINICAL LICENSING EXAMINATION (REGIONAL OR EQUIVALENT)

APPLICATION AND FEES

TO APPLY, CANDIDATES MUST SUBMIT:

- COMPLETED APPLICATION FORM
- PROOF OF EDUCATION AND EXAM SCORES
- BACKGROUND CHECK CONSENT
- APPLICATION FEE (VARIES)

LICENSE RENEWAL AND CONTINUING EDUCATION

DENTISTS AND HYGIENISTS MUST RENEW THEIR LICENSES PERIODICALLY, TYPICALLY EVERY TWO YEARS, AND COMPLETE CONTINUING EDUCATION REQUIREMENTS TO MAINTAIN LICENSURE.

DISCIPLINARY PROCEDURES AND PUBLIC COMPLAINTS

THE MARYLAND STATE BOARD OF DENTAL EXAMINERS MAINTAINS A TRANSPARENT PROCESS FOR HANDLING COMPLAINTS AND DISCIPLINARY ACTIONS.

FILING A COMPLAINT

MEMBERS OF THE PUBLIC OR PEERS CAN SUBMIT COMPLAINTS REGARDING:

- UNPROFESSIONAL CONDUCT
- SUBSTANDARD CARE
- FRAUD OR MISREPRESENTATION
- UNETHICAL BEHAVIOR

COMPLAINTS CAN BE SUBMITTED ONLINE, VIA MAIL, OR IN PERSON.

INVESTIGATION AND RESOLUTION

UPON RECEIVING A COMPLAINT, THE BOARD INVESTIGATES THE MATTER THOROUGHLY, WHICH MAY INCLUDE:

- REVIEW OF PATIENT RECORDS
- INTERVIEWS WITH INVOLVED PARTIES
- INSPECTION OF THE PRACTICE LOCATION

IF VIOLATIONS ARE CONFIRMED, THE BOARD CAN IMPOSE SANCTIONS RANGING FROM FINES TO LICENSE REVOCATION.

APPEALS PROCESS

PRACTITIONERS HAVE THE RIGHT TO APPEAL DISCIPLINARY DECISIONS THROUGH FORMAL PROCEDURES OUTLINED BY THE BOARD.

YOU CAN VERIFY A DENTIST'S LICENSE BY VISITING THE MARYLAND STATE BOARD OF DENTAL EXAMINERS' OFFICIAL WEBSITE AND USING THEIR ONLINE LICENSE VERIFICATION TOOL.

WHAT ARE THE REQUIREMENTS TO BECOME A LICENSED DENTIST IN MARYLAND?

APPLICANTS MUST GRADUATE FROM AN ACCREDITED DENTAL SCHOOL, PASS THE NATIONAL BOARD DENTAL EXAMINATION, COMPLETE THE CLINICAL LICENSING EXAMS APPROVED BY THE BOARD, AND SUBMIT A LICENSE APPLICATION WITH NECESSARY FEES.

HOW DOES THE MARYLAND STATE BOARD OF DENTAL EXAMINERS HANDLE DISCIPLINARY ACTIONS?

THE BOARD INVESTIGATES COMPLAINTS, CONDUCTS HEARINGS, AND CAN DISCIPLINE LICENSEES THROUGH SANCTIONS SUCH AS SUSPENSION, REVOCATION, OR FINES IF VIOLATIONS OF REGULATIONS OR PROFESSIONAL MISCONDUCT ARE FOUND.

WHAT ARE THE CONTINUING EDUCATION REQUIREMENTS FOR MARYLAND DENTISTS?

LICENSED DENTISTS IN MARYLAND ARE REQUIRED TO COMPLETE A SPECIFIC NUMBER OF CONTINUING EDUCATION HOURS EVERY RENEWAL CYCLE, TYPICALLY FOCUSING ON UPDATES IN DENTAL PRACTICES, SAFETY, AND ETHICS, AS MANDATED BY THE BOARD.

HOW CAN I FILE A COMPLAINT AGAINST A DENTAL PROFESSIONAL IN MARYLAND?

COMPLAINTS CAN BE FILED ONLINE THROUGH THE MARYLAND STATE BOARD OF DENTAL EXAMINERS' WEBSITE OR BY SUBMITTING A WRITTEN COMPLAINT TO THE BOARD'S OFFICE, PROVIDING DETAILED INFORMATION ABOUT THE ISSUE.

ARE TEMPORARY OR LIMITED LICENSES AVAILABLE THROUGH THE MARYLAND STATE BOARD OF DENTAL EXAMINERS?

YES, THE BOARD ISSUES TEMPORARY AND LIMITED LICENSES FOR SPECIFIC PURPOSES SUCH AS DENTAL EMERGENCIES, RESEARCH, OR SPECIAL CIRCUMSTANCES, SUBJECT TO CERTAIN ELIGIBILITY CRITERIA.

AS THE GOVERNING BODY, MSBDE ENSURES THAT DENTAL CARE PROVIDERS UPHOLD HIGH STANDARDS OF PRACTICE, ETHICS, AND SAFETY, FOSTERING TRUST BETWEEN DENTAL PROFESSIONALS AND THE COMMUNITY THEY SERVE.

HISTORICAL BACKGROUND AND EVOLUTION OF THE MARYLAND STATE BOARD OF DENTAL EXAMINERS

ORIGINS AND ESTABLISHMENT

THE MARYLAND STATE BOARD OF DENTAL EXAMINERS WAS ESTABLISHED IN THE EARLY 20TH CENTURY AS PART OF BROADER EFFORTS TO REGULATE HEALTH PROFESSIONS IN THE STATE. ITS FOUNDING AIMED TO FORMALIZE THE LICENSING PROCESS FOR DENTISTS, ENSURE QUALITY ASSURANCE, AND PROTECT THE PUBLIC FROM UNQUALIFIED PRACTITIONERS.

EVOLUTION OVER THE YEARS

OVER THE DECADES, MSBDE HAS EVOLVED TO ADDRESS EMERGING CHALLENGES IN DENTAL CARE, SUCH AS ADVANCES IN DENTAL TECHNOLOGY, THE RISE OF DENTAL AUXILIARIES LIKE DENTAL HYGIENISTS AND ASSISTANTS, AND THE NEED FOR UPDATED ETHICAL STANDARDS. THE BOARD HAS ALSO EXPANDED ITS AUTHORITY TO INCLUDE DISCIPLINARY ACTIONS, COMPLAINT INVESTIGATIONS, AND CONTINUING EDUCATION OVERSIGHT.

LEGISLATIVE FRAMEWORK

MSBDE OPERATES UNDER THE MARYLAND DENTAL ACT, CODIFIED IN THE MARYLAND ANNOTATED CODE, WHICH DELINEATES ITS POWERS, RESPONSIBILITIES, AND OPERATIONAL PROCEDURES. AMENDMENTS TO THIS LEGISLATION HAVE OFTEN RESPONDED TO DEVELOPMENTS IN DENTAL SCIENCE, PUBLIC HEALTH NEEDS, AND LEGAL CONSIDERATIONS.

ORGANIZATIONAL STRUCTURE AND MEMBERSHIP

COMPOSITION OF THE BOARD

THE MARYLAND STATE BOARD OF DENTAL EXAMINERS COMPRISES LICENSED DENTAL PROFESSIONALS AND PUBLIC MEMBERS APPOINTED BY THE GOVERNOR. TYPICALLY, THE BOARD INCLUDES:

- LICENSED DENTISTS REPRESENTING VARIOUS SPECIALTIES
- DENTAL HYGIENISTS
- PUBLIC MEMBERS WITH NO PROFESSIONAL TIES TO DENTISTRY
- ADMINISTRATIVE STAFF SUPPORTING REGULATORY FUNCTIONS

ROLES AND RESPONSIBILITIES

THE BOARD MEMBERS ARE TASKED WITH:

- LICENSING QUALIFIED DENTAL PRACTITIONERS
- CREATING AND UPDATING PRACTICE STANDARDS AND REGULATIONS
- CONDUCTING DISCIPLINARY HEARINGS
- OVERSEEING CONTINUING EDUCATION PROGRAMS
- RESPONDING TO PUBLIC INQUIRIES AND COMPLAINTS

MEETINGS AND DECISION-MAKING

MSBDE HOLDS REGULAR MEETINGS—OFTEN QUARTERLY—TO DISCUSS LICENSING APPLICATIONS, REVIEW DISCIPLINARY CASES, AND UPDATE REGULATIONS. DECISIONS ARE MADE COLLECTIVELY, ENSURING TRANSPARENCY AND ADHERENCE TO LEGAL STANDARDS.

LICENSING PROCEDURES AND REQUIREMENTS

LICENSURE PATHWAYS

OBTAINING A DENTAL LICENSE IN MARYLAND INVOLVES SEVERAL PATHWAYS, INCLUDING:

- GRADUATION FROM AN ACCREDITED DENTAL SCHOOL
- PASSING THE NATIONAL BOARD DENTAL EXAMINATION (NBDE) OR ITS SUCCESSOR EXAMS
- PASSING THE CLINICAL DENTAL EXAMINATION APPROVED BY THE BOARD
- DEMONSTRATING GOOD MORAL CHARACTER AND PROFESSIONAL INTEGRITY

APPLICATION PROCESS

APPLICANTS MUST SUBMIT COMPREHENSIVE DOCUMENTATION, INCLUDING:

- ACADEMIC TRANSCRIPTS
- EXAMINATION SCORES
- BACKGROUND CHECKS
- PROOF OF CLINICAL COMPETENCE AND ETHICS

ONCE APPROVED, CANDIDATES ARE TYPICALLY GRANTED A LICENSE VALID FOR A SPECIFIED PERIOD, SUBJECT TO RENEWAL AND CONTINUING EDUCATION REQUIREMENTS.

SPECIAL LICENSES AND PERMITS

BEYOND GENERAL PRACTICE LICENSES, MSBDE ISSUES PERMITS FOR SPECIFIC ROLES SUCH AS:

- DENTAL HYGIENISTS
- DENTAL ASSISTANTS
- TEMPORARY OR LIMITED LICENSES FOR INTERNATIONAL OR VISITING PRACTITIONERS

CONTINUING EDUCATION AND PROFESSIONAL DEVELOPMENT

MANDATED REQUIREMENTS

TO MAINTAIN LICENSURE, MARYLAND DENTISTS AND DENTAL HYGIENISTS ARE REQUIRED TO COMPLETE A SET NUMBER OF CONTINUING EDUCATION (CE) HOURS PERIODICALLY—USUALLY EVERY TWO YEARS. THESE CE ACTIVITIES AIM TO:

- UPDATE PRACTITIONERS ON THE LATEST DENTAL TECHNIQUES AND RESEARCH

- REINFORCE ETHICAL AND LEGAL STANDARDS
- PROMOTE PATIENT SAFETY AND QUALITY CARE

APPROVED PROGRAMS AND COURSES

THE BOARD APPROVES SPECIFIC COURSES, WHICH MAY INCLUDE:

- LIVE SEMINARS AND WORKSHOPS
- ONLINE WEBINARS AND MODULES
- CONFERENCES ORGANIZED BY RECOGNIZED PROFESSIONAL ASSOCIATIONS

RECORD-KEEPING AND COMPLIANCE

PRACTITIONERS MUST MAINTAIN RECORDS OF COMPLETED CE CREDITS AND SUBMIT PROOF DURING LICENSE RENEWAL. THE BOARD PERIODICALLY AUDITS COMPLIANCE TO ENSURE ONGOING PROFESSIONAL DEVELOPMENT.

DISCIPLINARY ACTIONS AND COMPLAINT RESOLUTION

SOURCES OF COMPLAINTS

THE MSBDE RECEIVES COMPLAINTS FROM PATIENTS, COLLEAGUES, OR OTHER STAKEHOLDERS REGARDING:

- UNPROFESSIONAL CONDUCT
- SUBSTANDARD OR NEGLIGENT TREATMENT
- ETHICAL VIOLATIONS
- LICENSING VIOLATIONS

INVESTIGATION PROCESS

UPON RECEIVING A COMPLAINT, THE BOARD CONDUCTS A THOROUGH INVESTIGATION, WHICH MAY INVOLVE:

- REVIEWING PATIENT RECORDS
- INTERVIEWING INVOLVED PARTIES
- CONSULTING WITH EXPERT PRACTITIONERS
- GATHERING ADDITIONAL EVIDENCE

DISCIPLINARY MEASURES

BASED ON FINDINGS, THE BOARD CAN IMPOSE A RANGE OF SANCTIONS, INCLUDING:

- REPRIMANDS OR CENSURE
- FINES
- PROBATION
- SUSPENSION OR REVOCATION OF LICENSE
- MANDATORY EDUCATION OR COUNSELING

APPEALS AND DUE PROCESS

PRACTITIONERS HAVE THE RIGHT TO APPEAL DISCIPLINARY DECISIONS THROUGH ADMINISTRATIVE HEARINGS, ENSURING FAIRNESS AND DUE PROCESS IN ENFORCEMENT ACTIONS.

PUBLIC OUTREACH, EDUCATION, AND ADVOCACY

CONSUMER EDUCATION INITIATIVES

MSBDE ACTIVELY PROMOTES PUBLIC AWARENESS ABOUT DENTAL HEALTH AND PATIENT RIGHTS THROUGH:

- INFORMATIONAL CAMPAIGNS
- EDUCATIONAL MATERIALS ABOUT CHOOSING QUALIFIED PRACTITIONERS
- GUIDANCE ON REPORTING CONCERNS

PROFESSIONAL SUPPORT AND RESOURCES

THE BOARD PROVIDES RESOURCES FOR LICENSEES, INCLUDING:

- PRACTICE GUIDELINES
- UPDATES ON LEGAL AND ETHICAL STANDARDS
- CONTINUING EDUCATION OPPORTUNITIES

ADVOCACY FOR PUBLIC HEALTH
