GOD: THE CREATOR AND RULER OF THE UNIVERSE

SEVENTH-DAY ADVENTISTS BELIEVE THAT GOD IS THE ETERNAL, ALL-POWERFUL, AND ALL-LOVING CREATOR WHO EXISTS AS THREE PERSONS—FATHER, SON, AND HOLY SPIRIT.

THE TRINITY

- GOD THE FATHER: THE CREATOR AND SUSTAINER OF ALL LIFE.
- JESUS CHRIST: THE SON, WHO INCARNATED TO BRING SALVATION.
- THE HOLY SPIRIT: THE DIVINE PRESENCE GUIDING AND EMPOWERING BELIEVERS.

GOD'S ATTRIBUTES

- LOVE: THE FUNDAMENTAL ATTRIBUTE OF GOD'S CHARACTER.
- OMNISCIENCE: ALL-KNOWING AND WISE.
- OMNIPOTENCE: ALL-POWERFUL.
- OMNIPRESENCE: PRESENT EVERYWHERE.
- HOLY: COMPLETELY PURE AND SEPARATE FROM SIN.

THE BIBLE: THE SOLE AUTHORITY FOR FAITH AND PRACTICE

ADVENTISTS UPHOLD THE BIBLE AS THE INSPIRED WORD OF GOD, AUTHORITATIVE AND SUFFICIENT FOR GUIDING FAITH AND LIFE.

INSPIRATION OF SCRIPTURE

- THE BIBLE IS DIVINELY INSPIRED AND ACCURATE IN ITS TEACHINGS.
- IT IS THE ULTIMATE AUTHORITY FOR DOCTRINE, CONDUCT, AND FAITH.

SCRIPTURAL PRINCIPLES

- CLEAR GUIDANCE FOR SALVATION, MORALITY, AND CHRISTIAN LIVING.
- PROPHETIC MESSAGES, ESPECIALLY IN THE BOOKS OF DANIEL AND REVELATION.

THE PLAN OF SALVATION

THE SEVENTH-DAY ADVENTIST CHURCH IS A WORLDWIDE COMMUNITY COMMITTED TO WORSHIP, FELLOWSHIP, AND MISSION.

THE NATURE OF THE CHURCH

- THE CHURCH IS THE SPIRITUAL BODY OF CHRIST, COMPOSED OF BELIEVERS.

MISSION OF THE CHURCH

THE TEN COMMANDMENTS AND MORAL PRINCIPLES

ADVENTISTS EMPHASIZE ADHERENCE TO GOD'S MORAL LAW, INCLUDING THE OBSERVANCE OF THE TEN COMMANDMENTS.

THE SABBATH

- OBSERVANCE OF THE SEVENTH-DAY SABBATH (SATURDAY) AS A DAY OF REST AND WORSHIP.
- IT SYMBOLIZES GOD'S CREATION AND REDEMPTION.

OTHER MORAL LAWS

- RESPECT FOR LIFE, HONESTY, PURITY, AND SOCIAL JUSTICE.
- PROMOTION OF A HEALTHY LIFESTYLE, INCLUDING ABSTINENCE FROM ALCOHOL AND TOBACCO.

THE GREAT CONTROVERSY AND SECOND COMING

THE GREAT CONTROVERSY

- A SPIRITUAL BATTLE BETWEEN CHRIST AND SATAN THAT INFLUENCES HUMAN HISTORY.
- GOD'S ULTIMATE VICTORY WILL BE REALIZED THROUGH CHRIST'S RETURN.

SECOND COMING OF CHRIST

- JESUS WILL RETURN VISIBLY, PERSONALLY, AND GLORIOUSLY.
- THIS EVENT WILL BRING RESURRECTION, JUDGMENT, AND THE BEGINNING OF ETERNAL LIFE OR DEATH.

RESURRECTION, JUDGMENT, AND ETERNITY

THE SDA BELIEFS ABOUT THE FUTURE INVOLVE THE RESURRECTION OF THE DEAD, FINAL JUDGMENT, AND ETERNAL DESTINATIONS.

THE RESURRECTION

- BELIEVERS WILL BE RESURRECTED TO ETERNAL LIFE.
- UNBELIEVERS WILL FACE RESURRECTION TO CONDEMNATION.

THE JUDGMENT

- CHRIST IS THE JUDGE WHO EXAMINES EACH PERSON'S LIFE.
- THE JUDGMENT IS BASED ON FAITH IN CHRIST AND MORAL CONDUCT.

ETERNAL LIFE AND DEATH

- BELIEVERS WILL ENJOY ETERNAL LIFE IN HEAVEN.
- THOSE WHO REJECT GOD FACE ETERNAL SEPARATION FROM HIM.

THE HEALTH MESSAGE AND STEWARDSHIP

ADVENTISTS PROMOTE HOLISTIC HEALTH AND RESPONSIBLE STEWARDSHIP OF RESOURCES.

HEALTH PRINCIPLES

- EMPHASIS ON A VEGETARIAN DIET, EXERCISE, AND ABSTINENCE FROM HARMFUL SUBSTANCES.
- THE BODY IS THE TEMPLE OF THE HOLY SPIRIT.

STEWARDSHIP

- RESPONSIBLE MANAGEMENT OF FINANCES, TIME, AND TALENTS.
- SUPPORTING MISSION WORK AND COMMUNITY SERVICE.

ADDITIONAL BELIEFS AND ETHICAL STANDARDS

THROUGH CHURCH CLASSES, STUDY GUIDES, LITERATURE, AND PERSONAL STUDY, OFTEN INTRODUCED DURING BAPTISMAL CLASSES OR NEW MEMBER ORIENTATION.

CAN SOMEONE OUTSIDE THE SDA CHURCH LEARN ABOUT THE 28 FUNDAMENTAL BELIEFS?

ABSOLUTELY. THE BELIEFS ARE PUBLICLY AVAILABLE AND SERVE AS A RESOURCE FOR ANYONE INTERESTED IN UNDERSTANDING SEVENTH-DAY ADVENTIST DOCTRINE AND FAITH PRACTICES.

- SOME MAY DESIRE MORE EMPHASIS ON HUMAN EFFORT IN SALVATION.

5. THE EXPERIENCE OF SALVATION

SALVATION IS BY FAITH ALONE THROUGH CHRIST, INVOLVING REGENERATION AND SANCTIFICATION.

FEATURES:

- IT IS A GIFT FROM GOD.
- IT INVOLVES A PERSONAL DECISION AND ONGOING GROWTH.
- THE BELIEVER IS CALLED TO LIVE A CHRISTLIKE LIFE.

PROS:

- PROMOTES ASSURANCE AND HOPE.
- ENCOURAGES MORAL AND SPIRITUAL GROWTH.

PROS:

- MOTIVATES EVANGELISM AND OUTREACH.
- REINFORCES FAITHFULNESS TO BIBLICAL TEACHINGS.

CONS:

- THE CONCEPT OF BEING “REMNANT” CAN SOMETIMES FOSTER EXCLUSIVITY.
- MISSION EFFORTS REQUIRE SIGNIFICANT RESOURCES.

9. UNITY IN THE BODY OF CHRIST

10. THE SABBATH

SEVENTH-DAY ADVENTISTS OBSERVE THE SEVENTH-DAY SABBATH FROM FRIDAY SUNSET TO SATURDAY SUNSET, AS A MEMORIAL OF CREATION.

FEATURES:

- IT IS A DAY OF REST, WORSHIP, AND SPIRITUAL RENEWAL.
- IT SIGNIFIES TRUST IN GOD’S CREATIVE POWER.
- IT IS DISTINCT FROM SUNDAY WORSHIP OBSERVED BY MANY OTHER CHRISTIAN GROUPS.

PROS:

- PROVIDES REGULAR SPIRITUAL REFRESHMENT.
- EMPHASIZES THE IMPORTANCE OF REST AND WORSHIP.

CONS:

- OBSERVANCE MAY BE CHALLENGING IN SECULAR OR WORK ENVIRONMENTS.
- CULTURAL ADAPTATION CAN VARY.

11. THE NATURE OF THE LAW OF GOD

THE LAW REFLECTS GOD’S CHARACTER AND MORAL STANDARDS, INCLUDING THE TEN COMMANDMENTS.
