TEXAS BOARD OF CHIROPRACTIC EXAMINERS: ENSURING SAFE AND ETHICAL CHIROPRACTIC PRACTICE IN TEXAS

THE **TEXAS BOARD OF CHIROPRACTIC EXAMINERS** (TBCE) PLAYS A CRUCIAL ROLE IN REGULATING THE CHIROPRACTIC PROFESSION WITHIN THE LONE STAR STATE. AS THE AUTHORITATIVE GOVERNING BODY, IT IS RESPONSIBLE FOR LICENSING QUALIFIED CHIROPRACTORS, SETTING PROFESSIONAL STANDARDS, AND ENSURING THAT CHIROPRACTIC PRACTITIONERS ADHERE TO ETHICAL AND SAFETY GUIDELINES. FOR RESIDENTS SEEKING CHIROPRACTIC CARE OR ASPIRING PRACTITIONERS, UNDERSTANDING THE FUNCTIONS AND RESPONSIBILITIES OF THE TBCE IS ESSENTIAL TO ENSURE QUALITY, SAFETY, AND COMPLIANCE WITHIN THE CHIROPRACTIC FIELD IN TEXAS.

OVERVIEW OF THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS

THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS WAS ESTABLISHED TO OVERSEE THE LICENSING, REGULATION, AND DISCIPLINE OF CHIROPRACTORS PRACTICING IN TEXAS. ITS PRIMARY MISSION IS TO PROTECT THE PUBLIC BY ENSURING THAT THOSE HOLDING A CHIROPRACTIC LICENSE MEET RIGOROUS STANDARDS OF EDUCATION, COMPETENCE, AND ETHICAL CONDUCT.

HISTORY AND FORMATION

THE TBCE WAS CREATED IN RESPONSE TO THE GROWING DEMAND FOR REGULATION OF CHIROPRACTIC PRACTICE IN TEXAS. IT FUNCTIONS AS A STATE AGENCY GOVERNED BY A BOARD COMPOSED OF LICENSED CHIROPRACTORS AND PUBLIC MEMBERS. OVER THE YEARS, THE TBCE HAS EVOLVED TO ADDRESS EMERGING ISSUES IN CHIROPRACTIC CARE AND TO UPHOLD THE INTEGRITY OF THE PROFESSION.

LEGAL AUTHORITY AND REGULATIONS

THE BOARD OPERATES UNDER THE TEXAS OCCUPATIONS CODE, SPECIFICALLY CHAPTER 201, WHICH OUTLINES THE SCOPE OF PRACTICE, LICENSING REQUIREMENTS, AND DISCIPLINARY PROCEDURES. ITS AUTHORITY EXTENDS TO:

- ISSUING AND RENEWING CHIROPRACTIC LICENSES
- ESTABLISHING EDUCATIONAL AND PROFESSIONAL STANDARDS
- INVESTIGATING COMPLAINTS AND ENFORCING DISCIPLINARY ACTIONS
- SETTING CONTINUING EDUCATION REQUIREMENTS

LICENSING AND CERTIFICATION PROCESS

ONE OF THE CORE RESPONSIBILITIES OF THE TBCE IS TO ENSURE THAT ONLY QUALIFIED INDIVIDUALS PRACTICE CHIROPRACTIC CARE IN TEXAS. THE LICENSING PROCESS INVOLVES SEVERAL STEPS DESIGNED TO VERIFY AN APPLICANT'S EDUCATION, TRAINING, AND ETHICAL STANDING.

EDUCATIONAL REQUIREMENTS

APPLICANTS MUST GRADUATE FROM AN ACCREDITED CHIROPRACTIC COLLEGE RECOGNIZED BY THE TBCE. THE TYPICAL EDUCATIONAL PATHWAY INCLUDES:

- COMPLETING A DOCTOR OF CHIROPRACTIC (D.C.) DEGREE FROM AN ACCREDITED INSTITUTION
- PASSING THE NATIONAL BOARD OF CHIROPRACTIC EXAMINERS (NBCE) EXAMS
- OBTAINING PRACTICAL EXPERIENCE THROUGH SUPERVISED CLINICAL INTERNSHIPS

APPLICATION AND EXAMINATION

TO OBTAIN LICENSURE, CANDIDATES MUST SUBMIT AN APPLICATION TO THE TBCE, WHICH INCLUDES:

1. PROOF OF EDUCATIONAL QUALIFICATIONS
2. PASSING SCORES ON THE NBCE EXAMS
3. BACKGROUND CHECKS AND FINGERPRINTING
4. COMPLIANCE WITH OTHER STATE-SPECIFIC REQUIREMENTS

ONCE APPLICATIONS ARE APPROVED, CANDIDATES MUST PASS THE TEXAS JURISPRUDENCE EXAM, WHICH TESTS KNOWLEDGE OF STATE LAWS GOVERNING CHIROPRACTIC PRACTICE.

RENEWAL AND CONTINUING EDUCATION

CHIROPRACTORS LICENSED IN TEXAS ARE REQUIRED TO RENEW THEIR LICENSES PERIODICALLY, TYPICALLY EVERY TWO YEARS. RENEWAL INVOLVES:

- SUBMITTING RENEWAL APPLICATIONS AND FEES
- COMPLETING A SPECIFIED NUMBER OF CONTINUING EDUCATION (CE) HOURS, INCLUDING ETHICS AND SAFETY COURSES
- MAINTAINING PROFESSIONAL LIABILITY INSURANCE

SCOPE OF PRACTICE AND PROFESSIONAL STANDARDS

THE TBCE DELINEATES THE SCOPE OF PRACTICE FOR LICENSED CHIROPRACTORS, EMPHASIZING SAFE AND ETHICAL TREATMENT.

AUTHORIZED PRACTICES

CHIROPRACTORS IN TEXAS ARE PERMITTED TO:

- PERFORM SPINAL ADJUSTMENTS AND MANIPULATIONS
- USE DIAGNOSTIC IMAGING SUCH AS X-RAYS
- PROVIDE PATIENT EDUCATION ON MUSCULOSKELETAL HEALTH
- DEVELOP TREATMENT PLANS TAILORED TO INDIVIDUAL NEEDS

HOWEVER, THE SCOPE DOES NOT EXTEND TO PRESCRIBING DRUGS OR PERFORMING SURGICAL PROCEDURES, WHICH ARE OUTSIDE CHIROPRACTIC PRACTICE.

CODE OF ETHICS AND PROFESSIONAL CONDUCT

THE TBCE ENFORCES A STRICT CODE OF ETHICS THAT INCLUDES PRINCIPLES SUCH AS:

- MAINTAINING PATIENT CONFIDENTIALITY
- OBTAINING INFORMED CONSENT
- PROVIDING HONEST AND COMPETENT CARE
- AVOIDING CONFLICTS OF INTEREST

VIOLATIONS OF THESE STANDARDS CAN RESULT IN DISCIPLINARY ACTIONS, INCLUDING SUSPENSION OR REVOCATION OF LICENSES.

DISCIPLINARY ACTIONS AND COMPLAINT RESOLUTION

THE TBCE MAINTAINS PROCEDURES TO INVESTIGATE COMPLAINTS AGAINST CHIROPRACTORS AND TAKE DISCIPLINARY ACTIONS WHEN NECESSARY.

COMMON REASONS FOR DISCIPLINARY ACTION

DISCIPLINARY MEASURES MAY BE TAKEN FOR ISSUES SUCH AS:

- PRACTICING WITHOUT A VALID LICENSE
- UNPROFESSIONAL CONDUCT OR MALPRACTICE
- FRAUDULENT BILLING OR INSURANCE FRAUD

- SUBSTANCE ABUSE IMPAIRING PROFESSIONAL JUDGMENT

COMPLAINT PROCESS

PATIENTS OR THIRD PARTIES CAN FILE COMPLAINTS WITH THE TBCE, WHICH THEN:

1. INVESTIGATES THE ALLEGATIONS
2. PROVIDES AN OPPORTUNITY FOR THE CHIROPRACTOR TO RESPOND
3. IMPOSES SANCTIONS IF VIOLATIONS ARE CONFIRMED

SANCTIONS MAY INCLUDE FINES, PROBATION, SUSPENSION, OR LICENSE REVOCATION, DEPENDING ON THE SEVERITY OF THE VIOLATION.

PUBLIC RESOURCES AND SUPPORT

THE TBCE OFFERS VARIOUS RESOURCES TO BOTH THE PUBLIC AND PRACTITIONERS TO PROMOTE TRANSPARENCY AND SUPPORT.

CONSUMER PROTECTION

PATIENTS CAN ACCESS INFORMATION ABOUT LICENSED CHIROPRACTORS, INCLUDING LICENSE STATUS, DISCIPLINARY HISTORY, AND PRACTICE LOCATIONS VIA THE TBCE WEBSITE. THIS TRANSPARENCY HELPS CONSUMERS MAKE INFORMED DECISIONS AND AVOID UNLICENSED PRACTITIONERS.

PROFESSIONAL DEVELOPMENT AND RESOURCES

CHIROPRACTORS CAN FIND GUIDANCE ON LICENSING RENEWAL, CONTINUING EDUCATION OPPORTUNITIES, AND UPDATES ON LEGAL OR PROCEDURAL CHANGES THROUGH THE TBCE'S OFFICIAL CHANNELS.

FUTURE TRENDS AND CHALLENGES IN CHIROPRACTIC REGULATION

AS HEALTHCARE EVOLVES, SO DOES THE REGULATORY LANDSCAPE.

INTEGRATION WITH MAINSTREAM HEALTHCARE

WHAT IS THE ROLE OF THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS?

THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS REGULATES THE LICENSING, PRACTICE, AND STANDARDS OF CHIROPRACTORS IN TEXAS TO ENSURE PUBLIC SAFETY AND PROFESSIONAL COMPETENCE.

WHAT ARE THE REQUIREMENTS TO BECOME LICENSED AS A CHIROPRACTOR IN TEXAS?

APPLICANTS MUST GRADUATE FROM AN ACCREDITED CHIROPRACTIC COLLEGE, PASS THE NATIONAL BOARD OF CHIROPRACTIC EXAMINERS EXAMS, AND PASS THE TEXAS JURISPRUDENCE EXAM, AMONG OTHER REQUIREMENTS.

HOW DOES THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS HANDLE COMPLAINTS AGAINST CHIROPRACTORS?

THE BOARD INVESTIGATES ALL COMPLAINTS THOROUGHLY AND MAY TAKE DISCIPLINARY ACTION, INCLUDING SUSPENSION OR REVOCATION OF LICENSES, IF VIOLATIONS OF LAWS OR STANDARDS ARE FOUND.

ARE THERE CONTINUING EDUCATION REQUIREMENTS FOR LICENSED CHIROPRACTORS IN TEXAS?

YES, LICENSED CHIROPRACTORS IN TEXAS MUST COMPLETE A SPECIFIED NUMBER OF CONTINUING EDUCATION HOURS EVERY RENEWAL PERIOD TO MAINTAIN THEIR LICENSE.

ADDITIONAL RESOURCES

THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS (TBCE) IS A PIVOTAL REGULATORY AUTHORITY RESPONSIBLE FOR OVERSEEING THE LICENSURE, REGULATION, AND DISCIPLINE OF CHIROPRACTIC PRACTITIONERS WITHIN THE STATE OF TEXAS. FOR ANYONE CONSIDERING ENTERING THE CHIROPRACTIC PROFESSION IN TEXAS OR SEEKING CHIROPRACTIC SERVICES, UNDERSTANDING THE ROLE, FUNCTIONS, AND STANDARDS SET FORTH BY THE TBCE IS ESSENTIAL.

OVERVIEW OF THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS

THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS WAS ESTABLISHED TO REGULATE THE PRACTICE OF CHIROPRACTIC MEDICINE WITHIN TEXAS. ITS PRIMARY MISSION IS TO PROTECT THE PUBLIC BY ENSURING CHIROPRACTORS MEET ESTABLISHED STANDARDS OF COMPETENCY, ETHICS, AND PROFESSIONALISM. THE TBCE OPERATES UNDER THE AUTHORITY OF THE TEXAS MEDICAL BOARD AND THE TEXAS OCCUPATIONS CODE, SPECIFICALLY TITLE 3, CHAPTER 201, WHICH DEFINES THE SCOPE AND REGULATION OF CHIROPRACTIC PRACTICE.

THE BOARD'S RESPONSIBILITIES INCLUDE LICENSURE, RENEWAL, DISCIPLINE, AND ENFORCEMENT ACTIVITIES. ADDITIONALLY, IT PROVIDES RESOURCES FOR LICENSEES, MAINTAINS PUBLIC RECORDS, AND ADVOCATES FOR BEST PRACTICES WITHIN THE PROFESSION. THE TBCE ALSO ENGAGES IN PUBLIC EDUCATION EFFORTS TO INFORM CONSUMERS ABOUT CHIROPRACTIC CARE AND HOW TO VERIFY LICENSED PRACTITIONERS.

LICENSING PROCESS AND REQUIREMENTS

OBTAINING A LICENSE FROM THE TEXAS BOARD OF CHIROPRACTIC EXAMINERS INVOLVES SEVERAL STEPS DESIGNED TO VERIFY THE APPLICANT'S QUALIFICATIONS AND ENSURE READINESS TO PRACTICE SAFELY AND ETHICALLY.

EDUCATIONAL REQUIREMENTS

- COMPLETION OF AN ACCREDITED DOCTOR OF CHIROPRACTIC (D.C.) PROGRAM APPROVED BY THE COUNCIL ON CHIROPRACTIC

EDUCATION (CCE).

- SUBMISSION OF OFFICIAL TRANSCRIPTS DEMONSTRATING GRADUATION FROM AN APPROVED PROGRAM.
- FULFILLMENT OF COURSEWORK IN ANATOMY, PHYSIOLOGY, MICROBIOLOGY, AND OTHER RELATED SCIENCES.

EXAMINATIONS

- PASSING SCORES ON THE NATIONAL BOARD OF CHIROPRACTIC EXAMINERS (NBCE) PARTS I, II, III, AND IV.
- SUCCESSFUL COMPLETION OF A JURISPRUDENCE EXAMINATION SPECIFIC TO TEXAS LAW.
- ADDITIONAL CLINICAL COMPETENCY ASSESSMENTS MAY BE REQUIRED.

APPLICATION PROCESS

- SUBMISSION OF A COMPLETED APPLICATION FORM ALONG WITH APPLICABLE FEES.
- PROVIDING PROOF OF EDUCATION, EXAMINATION RESULTS, AND GOOD MORAL CHARACTER.
- BACKGROUND CHECKS AND FINGERPRINTING ARE OFTEN PART OF THE PROCESS.

PROS:

- ENSURES ONLY QUALIFIED INDIVIDUALS ARE LICENSED.
- MAINTAINS HIGH STANDARDS FOR PATIENT SAFETY.

CONS:

- THE PROCESS CAN BE LENGTHY AND COSTLY FOR APPLICANTS.
- SOME APPLICANTS MAY FIND THE EXAMINATION REQUIREMENTS CHALLENGING.

LICENSING RENEWAL AND CONTINUING EDUCATION

ONCE LICENSED, CHIROPRACTORS IN TEXAS MUST RENEW THEIR LICENSES PERIODICALLY, TYPICALLY EVERY TWO YEARS, AND COMPLETE CONTINUING EDUCATION (CE) REQUIREMENTS TO MAINTAIN THEIR LICENSE VALIDITY.

RENEWAL PROCESS

- SUBMISSION OF RENEWAL APPLICATION AND FEE.
- COMPLETION OF REQUIRED CE CREDITS.
- SUBMISSION OF ANY NECESSARY DOCUMENTATION OR DISCLOSURES.

CONTINUING EDUCATION REQUIREMENTS

- A MINIMUM OF 24 HOURS OF CE EVERY RENEWAL CYCLE.
- COURSES MUST BE APPROVED BY THE TBCE AND RELEVANT TO CHIROPRACTIC PRACTICE.
- TOPICS OFTEN INCLUDE ETHICS, PATIENT SAFETY, NEW TECHNIQUES, AND LEGAL UPDATES.

FEATURES:

- ONLINE RENEWAL OPTIONS FOR CONVENIENCE.

- ACCESS TO APPROVED CE PROVIDERS ON THE TBCE WEBSITE.

PROS:

- PROMOTES ONGOING PROFESSIONAL DEVELOPMENT.
- KEEPS PRACTITIONERS UPDATED WITH CURRENT BEST PRACTICES.

CONS:

- THE CE REQUIREMENT MAY BE BURDENSOME FOR BUSY PRACTITIONERS.
- VARIABILITY IN COURSE QUALITY IF NOT CAREFULLY VETTED.

DISCIPLINE, COMPLAINTS, AND ENFORCEMENT

THE TBCE MAINTAINS A STRICT DISCIPLINE PROCESS TO ADDRESS VIOLATIONS OF LAWS, REGULATIONS, OR PROFESSIONAL STANDARDS. THIS HELPS UPHOLD THE INTEGRITY OF THE CHIROPRACTIC PROFESSION AND PROTECT THE PUBLIC.

COMPLAINT HANDLING

- PUBLIC OR PEER COMPLAINTS ARE INVESTIGATED THOROUGHLY.
- THE BOARD MAY CONDUCT HEARINGS OR AUDITS.
- VIOLATIONS CAN INCLUDE UNLICENSED PRACTICE, MALPRACTICE, FRAUD, OR ETHICAL BREACHES.

DISCIPLINARY ACTIONS

- REPRIMANDS OR CENSURE.
- LICENSE SUSPENSION OR REVOCATION.
- FINES OR OTHER PENALTIES.
- REQUIRED REMEDIAL EDUCATION OR MONITORING.

FEATURES:

- TRANSPARENT DISCIPLINARY PROCESS WITH PUBLIC RECORDS.
- OPTIONS FOR LICENSEE APPEALS.

PROS:

- ENSURES ACCOUNTABILITY AMONG PRACTITIONERS.

This study attempts to explore the life of chiropractors in light of all the historical and current changes taking place within the medical profession. It also seeks to understand the external and internal threats posed to chiropractors, with an eye towards understanding how and in what ways the future of medicine will impact the chiropractic profession. Despite the projected growth of job opportunities for chiropractors between 2014 and 2024, which, according to the U.S.

Department of Labor is occurring at a much faster than average trajectory than other professions (U.S. Department of Labor Statistics, 2015), given the costs involved in completing chiropractic training (which can exceed \$200,000) coupled with the low salary (recent data from the U.S.

Department of Labor Statistics shows that the median salary for a chiropractor is \$64,440 per year), along with the challenges of sustaining an individual practice (most chiropractors are self-employed in solo practice), these obstacles are formidable ones. This is particularly true in light of the recent development of large chiropractic chains such as the Joint, that offer spinal and neck adjustments at a fraction of the cost of a traditional provider. This ethnographic study consisted of systematic observation and interviews of 40 chiropractors in South Carolina from Fall 2016 to Fall 2017.

Additionally, interviews were conducted with staff members, patients, and other medical providers, such as physicians, physical therapists, massage therapists, and representatives from the insurance industry about their understanding and experiences with chiropractic medicine. Phone interviews were also conducted with seven deans and provosts at chiropractic colleges around the country. In total, over 100 interviews and informal conversations occurred during the course of the project. All identifiers of participants and chiropractic colleges in the study were removed to ensure anonymity. Instead, pseudonyms were created that were known only by the author of the study. Additionally, data from the South Carolina Department of Labor, Licensing and Regulation was obtained to

document changes in the number of chiropractors who are no longer in practice in the state between 2016 and 2017.
