- PREVENTS DELAYS OR MISCOMMUNICATION IN LEGAL OR FINANCIAL TRANSACTIONS
- HELPS MAINTAIN ACCURATE RECORDS FOR BOTH THE BORROWER AND THE LENDER

SPECIFIC LIENHOLDER ADDRESS FOR VEHICLE TITLES AND DOCUMENTATION

FOR TITLE AND REGISTRATION PURPOSES, WESTLAKE TYPICALLY USES A DESIGNATED LIENHOLDER ADDRESS SENT TO THE DMV OR OTHER STATE AGENCIES, WHICH IS OFTEN THE SAME AS THEIR MAIN ADDRESS BUT CAN DIFFER BASED ON JURISDICTION OR SPECIFIC CIRCUMSTANCES.

HOW TO USE THE WESTLAKE LIENHOLDER ADDRESS

1. UPDATING YOUR TITLE

WHEN PAYING OFF YOUR VEHICLE LOAN, YOUR LIEN MUST BE RELEASED. THE TITLE COMPANY OR DMV WILL REQUIRE THE OFFICIAL LIENHOLDER ADDRESS TO PROCESS THE LIEN RELEASE.

2. SENDING PAYMENTS

ENSURE YOUR PAYMENTS ARE DIRECTED TO THE CORRECT ADDRESS TO AVOID DELAYS OR MISAPPLIED PAYMENTS.

3. NOTIFYING OF CHANGES

IF YOU NEED TO UPDATE YOUR CONTACT INFORMATION OR NOTIFY WESTLAKE OF A DISPUTE, USE THE CORRECT LIENHOLDER ADDRESS FOR CORRESPONDENCE.

4. HANDLING LEGAL OR TITLE ISSUES
