EACH CATEGORY CONTAINS SPECIFIC PROCEDURE CODES (TYPICALLY ADA CODES) WITH ASSOCIATED FEE LIMITS. THESE CODES STANDARDIZE BILLING AND HELP ENSURE CONSISTENCY ACROSS PROVIDERS.

HOW TO ACCESS THE CIGNA DENTAL PPO FEE SCHEDULE 2023

SUPPOSE YOU NEED A ROUTINE EXAM CODED D0120. THE FEE SCHEDULE LISTS A MAXIMUM ALLOWABLE FEE OF \$50. IF YOUR IN-NETWORK DENTIST CHARGES \$45, CIGNA WILL REIMBURSE BASED ON THAT AMOUNT, AND YOUR COINSURANCE APPLIES ACCORDINGLY.

BENEFITS OF USING THE FEE SCHEDULE

UTILIZING THE FEE SCHEDULE OFFERS SEVERAL ADVANTAGES:

PROCEDURE CATEGORIES AND COVERED SERVICES

THE FEE SCHEDULE IS ORGANIZED INTO VARIOUS CATEGORIES BASED ON THE COMPLEXITY AND NATURE OF DENTAL PROCEDURES, SUCH AS:

- PREVENTIVE CARE: ROUTINE EXAMS, CLEANINGS, FLUORIDE TREATMENTS, SEALANTS

REIMBURSEMENT RATES AND MEMBER COSTS

THE SCHEDULE SPECIFIES THE PERCENTAGE OF THE MAXIMUM ALLOWABLE FEE THAT CIGNA WILL REIMBURSE FOR EACH PROCEDURE WHEN PERFORMED BY A PPO NETWORK PROVIDER, TYPICALLY RANGING FROM 70% TO 100%. MEMBERS ARE RESPONSIBLE FOR

PAYING THE DIFFERENCE BETWEEN THE PROVIDER'S CHARGE AND THE INSURER'S REIMBURSEMENT, ALONG WITH ANY APPLICABLE COPAYMENTS OR DEDUCTIBLES.

FOR EXAMPLE, IF THE FEE SCHEDULE LISTS A CROWN PROCEDURE AT A MAXIMUM FEE OF \$1,000, AND CIGNA REIMBURSES 80%, THE INSURER WOULD PAY \$800, AND THE MEMBER WOULD BE RESPONSIBLE FOR THE REMAINING \$200, UNLESS THE PROVIDER AGREES TO ACCEPT THE SCHEDULE FEE AS PAYMENT IN FULL.

REGIONAL VARIATIONS AND ADJUSTMENTS

GIVEN THE VARIABILITY IN DENTAL PRACTICE COSTS ACROSS DIFFERENT STATES AND REGIONS, CIGNA'S 2023 FEE SCHEDULE INCORPORATES REGIONAL ADJUSTMENTS. THESE ENSURE THAT PROVIDERS ARE FAIRLY REIMBURSED BASED ON LOCAL ECONOMIC FACTORS, AND MEMBERS HAVE TRANSPARENT EXPECTATIONS REGARDING COSTS.

- VARIABILITY IN PROVIDER CHARGES: SOME PROVIDERS MAY BILL ABOVE THE SCHEDULE'S MAXIMUM ALLOWABLE FEE, LEADING TO POTENTIAL MEMBER SURPRISE.
- COVERAGE RESTRICTIONS: NOT ALL PROCEDURES, ESPECIALLY COSMETIC OR ELECTIVE TREATMENTS, ARE FULLY COVERED OR INCLUDED IN THE SCHEDULE.
- OUT-OF-NETWORK COSTS: MEMBERS SEEKING CARE OUTSIDE THE NETWORK MAY FACE SIGNIFICANTLY HIGHER COSTS, AS THE FEE SCHEDULE PRIMARILY GUIDES IN-NETWORK REIMBURSEMENTS.
