ESSENTIAL COMPONENTS OF THE LETTER

A WELL-DRAFTED AUTHORIZATION LETTER SHOULD INCLUDE THE FOLLOWING DETAILS:

- **APPLICANT'S INFORMATION:** FULL NAME, DATE OF BIRTH, AND PASSPORT APPLICATION/REFERENCE NUMBER.
- **AUTHORIZED PERSON'S INFORMATION:** FULL NAME, RELATIONSHIP TO THE APPLICANT, CONTACT DETAILS, AND ID PROOF.

- **AUTHORIZATION STATEMENT:** CLEAR STATEMENT AUTHORIZING THE INDIVIDUAL TO COLLECT THE PASSPORT.
- **DATE AND PLACE:** THE DATE OF WRITING THE LETTER AND THE LOCATION.
- **SIGNATURE:** SIGNED BY THE APPLICANT OR PARENT/GUARDIAN IF MINOR.
- **CONTACT DETAILS:** PHONE NUMBER AND EMAIL FOR VERIFICATION IF NEEDED.

REQUIRED DOCUMENTS FOR PASSPORT COLLECTION WITH AUTHORIZATION

FOR THE APPLICANT

- ORIGINAL PASSPORT APPLICATION RECEIPT OR ACKNOWLEDGMENT SLIP
- VALID IDENTIFICATION PROOF (E.G., AADHAAR CARD, DRIVER'S LICENSE, VOTER ID)
- ORIGINAL OR PHOTOCOPY OF THE APPLICANT'S ID (IF REQUIRED)
- THE SIGNED AUTHORIZATION LETTER

FOR THE AUTHORIZED PERSON

- ORIGINAL VALID PHOTO ID (E.G., PAN CARD, AADHAAR, VOTER ID)
- A COPY OF THE APPLICANT'S ID OR PASSPORT ACKNOWLEDGMENT SLIP

WHAT SHOULD I DO IF I LOSE THE AUTHORIZATION LETTER FOR PASSPORT COLLECTION?

NECESSARY SUPPORTING DOCUMENTS

IN ADDITION TO THE AUTHORIZATION LETTER, APPLICANTS SHOULD PREPARE THE FOLLOWING DOCUMENTS:

- ORIGINAL AND PHOTOCOPY OF THE APPLICANT'S VALID ID (PASSPORT, DRIVER'S LICENSE, NATIONAL ID)
- ORIGINAL AND PHOTOCOPY OF THE AUTHORIZED PERSON'S ID
- RECEIPT OF THE PASSPORT APPLICATION OR COLLECTION SLIP
- ANY SPECIFIC FORMS REQUIRED BY THE ISSUING AUTHORITY
- NOTARIZATION DOCUMENTS (IF APPLICABLE)

ALWAYS VERIFY WITH THE RESPECTIVE PASSPORT ISSUING AUTHORITY BEFOREHAND FOR SPECIFIC DOCUMENT REQUIREMENTS.

PROCEDURAL STEPS FOR PASSPORT COLLECTION USING AUTHORIZATION LETTER

ENSURE ALL DOCUMENTS ARE COMPLETE, ACCURATE, AND LEGIBLE. IF NOTARIZATION IS REQUIRED, VISIT A NOTARY PUBLIC TO HAVE THE LETTER OFFICIALLY NOTARIZED.

STEP 2: VISIT THE PASSPORT OFFICE OR EMBASSY

THE AUTHORIZED PERSON SHOULD VISIT THE DESIGNATED LOCATION WITH THE AUTHORIZATION LETTER, THEIR ID, AND THE APPLICANT'S ID (IF REQUIRED).

STEP 3: SUBMIT THE DOCUMENTS

PRESENT THE AUTHORIZATION LETTER AND SUPPORTING DOCUMENTS TO THE DESIGNATED OFFICIAL. THEY MAY VERIFY DETAILS AND CHECK FOR ANY SPECIFIC REQUIREMENTS.

STEP 4: VERIFICATION PROCESS

THE AUTHORITY MAY VERIFY THE AUTHENTICITY OF THE AUTHORIZATION LETTER THROUGH PHONE CALLS, EMAIL, OR PHYSICAL INSPECTION. THEY MIGHT ALSO CHECK THE IDs.

STEP 5: RECEIVE THE PASSPORT

ONCE VERIFIED, THE AUTHORIZED PERSON CAN COLLECT THE PASSPORT. ENSURE TO GET AN ACKNOWLEDGMENT RECEIPT OR COLLECTION SLIP.

STEP 6: CONFIRM RECEIPT

AFTER COLLECTION, REVIEW THE PASSPORT FOR CORRECTNESS—NAME SPELLING, DATE OF BIRTH, PASSPORT NUMBER, ETC.—TO ENSURE EVERYTHING IS IN ORDER.

TIPS FOR A SMOOTH PASSPORT COLLECTION

- VERIFY REQUIREMENTS: ALWAYS CHECK THE OFFICIAL WEBSITE OR CONTACT THE PASSPORT OFFICE FOR THE LATEST PROCEDURES AND DOCUMENT REQUIREMENTS.
- DOUBLE-CHECK DETAILS: ENSURE ALL DETAILS IN THE AUTHORIZATION LETTER ARE ACCURATE TO AVOID DELAYS.
- PREPARE ORIGINALS AND COPIES: CARRY BOTH ORIGINAL IDs AND COPIES, AS AUTHORITIES OFTEN REQUIRE BOTH.
- ARRIVE EARLY: VISITING THE OFFICE EARLY IN THE DAY CAN HELP AVOID LAST-MINUTE RUSHES.
- KEEP COPIES OF THE AUTHORIZATION LETTER: FOR SECURITY AND RECORD-KEEPING PURPOSES.
- FOLLOW UP: IF THERE ARE DELAYS, CONTACT THE OFFICE TO CONFIRM THE STATUS OF THE PASSPORT.

IN CASE OF DIFFICULTIES, APPLICANTS CAN SEEK ASSISTANCE FROM LEGAL PROFESSIONALS OR CONSULT THE EMBASSY'S CUSTOMER SERVICE.
