GRESSAR'S WORK EXEMPLIFIES THE ONGOING EFFORT TO ENHANCE UNDERSTANDING AND TREATMENT OF SUD, CONTRIBUTING TO A FUTURE WHERE RECOVERY IS SUPPORTED BY PRECISE, EMPATHETIC, AND EVIDENCE-BASED APPROACHES. HIS EFFORTS SERVE AS A MODEL FOR ONGOING INNOVATION IN ADDICTION CARE, EMPHASIZING THAT RIGOROUS ASSESSMENT AND PERSONALIZED TREATMENT ARE CORNERSTONES OF EFFECTIVE INTERVENTION.
