- CONCENTRATION DIFFICULTIES

- SUICIDAL THOUGHTS

THE TOTAL SCORE CAN RANGE FROM 0 TO 63, WITH HIGHER SCORES INDICATING MORE SEVERE DEPRESSION.

INTERPRETING SCORES

WHILE INTERPRETATIONS MAY VARY, GENERAL GUIDELINES INCLUDE:

- 0–13: MINIMAL DEPRESSION
- 14–19: MILD DEPRESSION
- 20–28: MODERATE DEPRESSION
- 29–63: SEVERE DEPRESSION

CLINICIANS USE THESE CATEGORIES TO DETERMINE THE APPROPRIATE LEVEL OF INTERVENTION AND TO TRACK SYMPTOM PROGRESSION.

3. PAST FAILURE
4. LOSS OF PLEASURE
5. GUILTY FEELINGS
6. PUNISHMENT FEELINGS
7. SELF-DISLIKE
8. SELF-CRITICALNESS
9. SUICIDAL THOUGHTS OR WISHES
10. CRYING
11. AGITATION
12. LOSS OF INTEREST
13. INDECISIVENESS

14. WORTHLESSNESS
15. LOSS OF ENERGY
16. CHANGES IN SLEEPING PATTERN
17. IRRITABILITY
18. CHANGES IN APPETITE
19. CONCENTRATION DIFFICULTY
20. TIREDNESS OR FATIGUE
21. LOSS OF INTEREST IN SEX

How to Use the BDI-II PDF

STEP-BY-STEP GUIDE:

1. ADMINISTER THE QUESTIONNAIRE:

- PROVIDE THE BDI-II PDF TO THE INDIVIDUAL.
- ENSURE THEY UNDERSTAND THE INSTRUCTIONS: RESPOND BASED ON HOW THEY HAVE FELT OVER THE PAST TWO WEEKS.

2. COMPLETE THE RESPONSES:

- THE INDIVIDUAL SELECTS THE STATEMENT THAT BEST DESCRIBES THEIR EXPERIENCE FOR EACH ITEM.
- RESPONSES ARE TYPICALLY MARKED DIRECTLY ON THE PDF OR FILLED OUT ELECTRONICALLY.

3. SCORE THE RESPONSES:

- ASSIGN POINTS BASED ON THE SELECTED STATEMENT:
- 0 = SYMPTOM ABSENT OR MINIMAL
- 1 = MILD OR MODERATE SYMPTOMS
- 2 = MODERATE TO SEVERE SYMPTOMS
- 3 = SEVERE SYMPTOMS
- SUM THE SCORES OF ALL 21 ITEMS TO GET A TOTAL SCORE.

4. INTERPRET THE TOTAL SCORE:

- 0-13: MINIMAL DEPRESSION
- 14-19: MILD DEPRESSION
- 20-28: MODERATE DEPRESSION
- 29-63: SEVERE DEPRESSION

NOTE: THESE CATEGORIES ARE GUIDELINES; CLINICAL JUDGMENT IS ESSENTIAL FOR DIAGNOSIS.

5. USE RESULTS FOR CLINICAL OR RESEARCH PURPOSES:

- DECIDE ON TREATMENT PLANS, NEED FOR FURTHER ASSESSMENT, OR MONITOR CHANGES OVER TIME.

PRACTICAL TIPS FOR EFFECTIVE USE

- ENSURE CONFIDENTIALITY: WHEN ADMINISTERING THE BDI-II, ESPECIALLY IN CLINICAL OR RESEARCH SETTINGS, MAINTAIN CONFIDENTIALITY.
- COMBINE WITH OTHER ASSESSMENTS: USE ALONGSIDE CLINICAL INTERVIEWS AND OTHER TOOLS FOR COMPREHENSIVE EVALUATION.

LIMITATIONS OF THE BDI-II PDF
