- RISKS MARGINALIZING OR DEMONIZING GROUPS WITHOUT DUE CAUSE.

THE STORY OF THE COMMITTEE OF THREE HUNDRED EXEMPLIFIES HOW MYTHS CAN INFLUENCE PERCEPTIONS AND HOW THE HUMAN MIND SEEKS ORDER AND CONTROL IN A COMPLEX WORLD.

IN EXPLORING THIS LEGEND, WE GAIN INSIGHT NOT ONLY INTO THE CONSPIRACY THEORIES THEMSELVES BUT ALSO INTO THE SOCIETAL CONDITIONS THAT FOSTER SUCH BELIEFS.
