A chapter on treatment discusses therapy and medication, offering brief notes on various categories of medication. The book emphasizes the need to understand risks and benefits when deciding about any course of treatment. Subsequent sections focus on locating allies to promote recovery, finding resources to support recovery, planning both long-term and short-term, and following the recovery plan. The authors discuss planning for safety in advance of a mental health crisis, responding to a person in crisis, assessing risk of violence, and preventing suicide. The book suggests ways to help people who become involved in the criminal justice system, and covers involuntary hospitalization and guardianship. Further chapters discuss ways to locate treatment, find or retain housing, maintain employment or access vocational rehabilitation services. There is coverage of Social Security and SSI disability benefits and claims process, plus information about Medicare and Medicaid.
