isle of wight murder: Murder by Poison Nicola Sly, 2011-10-30 Murder by poison is often thought of as a crime mainly committed by women, usually to despatch an unwanted spouse or children. While there are indeed many infamous female poisoners, such as Mary Ann Cotton, who is believed to have claimed at least twenty victims between 1860 and 1872, and Mary Wilson, who killed her husbands and lovers in the 1950s for the proceeds of their insurance policies, there are also many men who chose poison as their preferred means to a deadly end. Dr Thomas Neil Cream poisoned five people between 1881 and 1892 and was connected with several earlier suspicious deaths, while Staffordshire doctor William Palmer murdered at least ten victims between 1842 and

1856. Readily obtainable and almost undetectable prior to advances in forensic science during the twentieth century, poison was considered the ideal method of murder and many of its exponents failed to stop at just one victim. Along with the most notorious case of murder by poison in the country, this book also features many of the cases that did not make national headlines, examining not only the methods and motives but also the real stories of the perpetrators and their victims.

Taken together, these cases uncover a world in which the mandates of segregation did not always hold sway, in which whites and blacks interacted in the most intimate of ways, and in which white women and white men saw their interests in conflict. In Dorr's account, cases of black-on-white rape illuminate the paradoxes at the heart of segregated southern society: the tension between civilization and savagery, the desire for orderly and predictable racial boundaries despite conflicts among whites and relationships across racial boundaries, and the dignity of African Americans in a system dependent on their supposed inferiority. The rhetoric of protecting white women spoke of white supremacy and patriarchy, but its practice revealed the limits of both.

The later chapters, however, feature more recent cold cases where there is still the possibility that the wicked men or women who were responsible for such acts of inhumanity may remain within our society. Cases include a man murdered for less than 70 in a city centre multi storey car park, a teenage girl abducted, sexually assaulted and left dead on a dung hill, a young mother who entered prostitution and died at the hands of a man with more than sex on his mind, a pregnant woman who left home one day to go shopping but was found days later dead in a ditch with her throat cut and a disabled woman who was strangled in her home which was then set ablaze. For some of these cases there is the chance that someone has information which, despite the passage of decades, could lead to one or more individuals standing trial for murder. Justice can still prevail.
