THE OFFICER OBSERVED WHISKERS' REACTIONS AND NOTED HIS FOCUS ON A SPECIFIC AREA OUTSIDE THE HOUSE. FOLLOWING THE CAT'S LEAD, POLICE OFFICERS SET UP SURVEILLANCE, WHICH ULTIMATELY LED TO THE APPREHENSION OF THE BURGLAR.

THE SCIENCE BEHIND FELINE INSTINCTS

SENSORY CAPABILITIES

- OLFACTION: CATS HAVE A HIGHLY DEVELOPED SENSE OF SMELL, WITH APPROXIMATELY 50 TO 80 MILLION OLFACTORY RECEPTORS. THIS ALLOWS THEM TO DETECT SCENTS LEFT BY HUMANS OR OTHER ANIMALS, EVEN DAYS AFTER AN EVENT.
- HEARING: THEIR ACUTE HEARING CAN PICK UP ULTRASONIC SOUNDS AND FAINT NOISES, ALERTING THEM TO UNUSUAL ACTIVITY.
- VISION: CATS ARE CREPUSCULAR ANIMALS, WITH EXCELLENT NIGHT VISION, ENABLING THEM TO DETECT MOVEMENT IN LOW LIGHT CONDITIONS.

BEHAVIORAL TRAITS FAVORING DETECTION

- CURIOSITY: CATS ARE NATURALLY INQUISITIVE, OFTEN INVESTIGATING NEW OBJECTS OR CHANGES IN THEIR ENVIRONMENT.
- TERRITORIALITY: THEY TEND TO BE HIGHLY TERRITORIAL, REACTING DEFENSIVELY OR INQUISITIVELY WHEN THEIR TERRITORY IS DISTURBED.

LIMITATIONS AND ETHICAL CONSIDERATIONS

- TRAINING DIFFICULTIES: CATS ARE INDEPENDENT AND LESS TRAINABLE THAN DOGS.
