THESE MONETIZATION TACTICS HAVE FUELED ACCUSATIONS THAT AGAINST THE I C E PRIORITIZES PROFIT OVER PLAYER EXPERIENCE, CONTRIBUTING TO ITS NEGATIVE PERCEPTION AMONG CERTAIN SEGMENTS OF THE COMMUNITY.

CONTROVERSIES AND ETHICAL CONCERNS

DESIGN CHOICES AND PLAYER MANIPULATION
