SO THE LORD GOD CAUSED THE MAN TO FALL INTO A DEEP SLEEP; AND WHILE HE WAS SLEEPING, HE TOOK ONE OF THE MAN'S RIBS AND CLOSED UP THE PLACE WITH FLESH. THEN THE LORD GOD MADE A WOMAN FROM THE RIB HE HAD TAKEN OUT OF THE MAN, AND HE BROUGHT HER TO THE MAN."

THIS ACCOUNT PROVIDES NO MENTION OF A PRIOR WIFE OR COMPANION BEFORE EVE. THE NAME "EVE" IS GIVEN LATER IN GENESIS 3:20, WHERE SHE IS IDENTIFIED AS ADAM'S WIFE.

KEY POINT: THE BIBLICAL NARRATIVE DOES NOT EXPLICITLY MENTION A FIRST WIFE OF ADAM BEFORE EVE. THE ABSENCE OF HER NAME AND DESCRIPTION HAS LED SCHOLARS TO QUESTION HER EXISTENCE WITHIN THE CANONICAL TEXTS.

ANCIENT TEXTS AND EXTRABIBLICAL TRADITIONS

DESPITE THE CANONICAL SILENCE, VARIOUS ANCIENT TRADITIONS AND TEXTS HAVE INTRODUCED THE FIGURE OF A WOMAN WHO PREDATES OR ACCOMPANIES EVE. THE MOST NOTABLE AMONG THESE IS THE BOOK OF GENESIS APOCRYPHON AND OTHER JEWISH MYSTICAL WRITINGS, WHICH SOMETIMES REFERENCE A "FIRST WIFE" OR A COMPANION IN EARLY NARRATIVES.

THE MYTH OF LILITH

PERHAPS THE MOST PROMINENT AND ENDURING FIGURE ASSOCIATED WITH THE "FIRST WIFE OF ADAM" OUTSIDE THE CANONICAL TEXTS IS LILITH. ORIGINATING FROM JEWISH MYSTICISM AND FOLKLORE, LILITH HAS BECOME A SYMBOL OF INDEPENDENCE, REBELLION, AND COMPLEX GENDER DYNAMICS.

ORIGINS OF LILITH IN JEWISH TRADITION

THE EARLIEST REFERENCES TO LILITH APPEAR IN THE BABYLONIAN TALMUD AND THE ALPHABET OF BEN SIRA (CIRCA 8TH-10TH CENTURIES CE). IN THESE SOURCES, LILITH IS DEPICTED AS:

- A FEMALE DEMON OR NIGHT SPIRIT WHO WAS CREATED AT THE SAME TIME AND FROM THE SAME EARTH AS ADAM.
- ADAM'S FIRST WIFE WHO REFUSED TO SUBMIT TO HIM AND SUBSEQUENTLY LEFT THE GARDEN OF EDEN.
- A FIGURE ASSOCIATED WITH SEDUCTION, INDEPENDENCE, AND SOMETIMES MALEVOLENT SPIRITS.

THE ALPHABET OF BEN SIRA ELABORATES THAT LILITH WAS CREATED FROM THE SAME DUST AS ADAM, IMPLYING EQUALITY IN ORIGIN, BUT SHE REFUSED TO BE SUBORDINATE AND LEFT EDEN VOLUNTARILY.

KEY ATTRIBUTES AND MYTHS

- EQUALITY AND REBELLION: LILITH'S REFUSAL TO SUBMIT MIRRORS LATER FEMINIST INTERPRETATIONS, SYMBOLIZING AUTONOMY.
- RETURN AND DEMONIZATION: LATER FOLKLORE DEPICTS HER AS A DEMONESS PREYING ON CHILDREN AND WOMEN IN CHILDBIRTH.

THE MYTH OF LILITH HAS PERMEATED VARIOUS CULTURES, INSPIRING LITERATURE, ART, AND PSYCHOANALYTIC THEORY. HER STORY RAISES QUESTIONS ABOUT GENDER ROLES, SUBMISSION, AND THE NATURE OF EQUALITY, REFLECTING EVOLVING SOCIETAL ATTITUDES TOWARDS WOMEN.

OTHER ACCOUNTS AND THEORIES

BEYOND LILITH, OTHER NARRATIVES AND THEORIES SPECULATE ABOUT THE EXISTENCE OF A PRIOR WIFE OR PARTNER OF ADAM.

THE Gnostic PERSPECTIVE

GNOSTIC TEXTS, SUCH AS THE ON THE ORIGIN OF THE WORLD AND THE GOSPEL OF PHILIP, MENTION A WOMAN NAMED SETH'S WIFE OR OTHER FIGURES LINKED TO ADAM'S LINEAGE. SOME Gnostic SECTS PROPOSED THE IDEA OF MULTIPLE DIVINE BEINGS AND COMPLEX COSMOLOGIES INVOLVING EARLY HUMAN PAIRINGS.

THE JEWISH MIDRASHIC INTERPRETATIONS

MIDRASHIC SOURCES, WHICH ARE RABBINIC COMMENTARIES AND EXPANSIONS ON BIBLICAL TEXTS, SOMETIMES MENTION A WOMAN NAMED LILIN OR NAAMAH AS ADAM'S FIRST WIFE OR A COMPANION BEFORE EVE. NAAMAH, IN PARTICULAR, IS SOMETIMES ASSOCIATED WITH THE LINEAGE OF NOAH AND IS CONSIDERED A FIGURE OF MYSTIC SIGNIFICANCE.

THE SUMERIAN AND MESOPOTAMIAN INFLUENCES

ANCIENT MESOPOTAMIAN MYTHOLOGY, SUCH AS THE SUMERIAN TALES OF INANNA AND ENKI, DEPICT COMPLEX RELATIONSHIPS BETWEEN GODS AND HUMANS. SOME SCHOLARS SUGGEST THAT THESE STORIES INFLUENCED LATER JUDAIC NARRATIVES AND MAY HAVE INDIRECTLY CONTRIBUTED TO IDEAS ABOUT PROTO-WIVES OR COMPANIONS.

MODERN INTERPRETATIONS AND CULTURAL SIGNIFICANCE

FEMINIST AND CULTURAL REINTERPRETATIONS

IN CONTEMPORARY DISCOURSE, THE FIGURE OF THE "FIRST WIFE OF ADAM"—PARTICULARLY LILITH—SERVES AS A SYMBOL OF:

- FEMALE INDEPENDENCE AND SOVEREIGNTY
- REJECTION OF OPPRESSIVE GENDER ROLES
- CHALLENGING TRADITIONAL INTERPRETATIONS OF BIBLICAL NARRATIVES

ARTISTS, WRITERS, AND THEORISTS HAVE EMBRACED LILITH AS AN ICON FOR FEMINISM, SPIRITUALITY, AND ALTERNATIVE HISTORIES OF WOMANHOOD.

SCIENTIFIC AND ARCHEOLOGICAL PERSPECTIVES

FROM AN ARCHAEOLOGICAL STANDPOINT, THERE IS NO DIRECT EVIDENCE OF A DISTINCT "FIRST WIFE" PREDATING EVE IN EARLY HUMAN SOCIETIES. EARLY HUMAN REMAINS AND CULTURAL ARTIFACTS DO NOT EXPLICITLY SUPPORT THE EXISTENCE OF SUCH A FIGURE, SUGGESTING THAT THESE STORIES ARE LARGELY MYTHOLOGICAL OR ALLEGORICAL.

INFLUENCE ON LITERATURE AND POPULAR CULTURE

THE MYTH OF ADAM'S FIRST WIFE HAS INSPIRED COUNTLESS WORKS:

- LITERATURE: POETS AND NOVELISTS HAVE EXPLORED HER STORY AS A METAPHOR FOR AUTONOMY.
- MEDIA: FILMS, COMICS, AND TELEVISION SERIES DEPICT LILITH AND SIMILAR FIGURES, OFTEN REIMAGINED AS COMPLEX CHARACTERS.
- SPIRITUALITY: SOME MODERN SPIRITUAL MOVEMENTS INCORPORATE LILITH INTO THEIR COSMOLOGIES AND PRACTICES.
