SCALE AND COMPLEXITY

RISK OF MARGINALIZATION

SINCE THE 1980S, PORTO ALEGRE HAS PIONEERED PARTICIPATORY BUDGETING, LEADING TO MORE EQUITABLE URBAN DEVELOPMENT, REDUCED CORRUPTION, AND INCREASED CIVIC TRUST.

CHALLENGES FACED:

- INITIALLY LIMITED TO CERTAIN DISTRICTS.
- RESISTANCE FROM TRADITIONAL BUREAUCRACIES.
- ENSURING CONTINUOUS ENGAGEMENT.

LESSON LEARNED: LONG-TERM COMMITMENT AND INSTITUTIONALIZATION ARE CRUCIAL FOR SUCCESS.

FAILURE EXAMPLE: LIMITED IMPACT IN SOME U.S. CITIES

- GLOBAL INITIATIVES: INTERNATIONAL ORGANIZATIONS EXPERIMENTING WITH CITIZEN ASSEMBLIES FOR GLOBAL ISSUES.

POTENTIAL DEVELOPMENTS:

CAUTION AND CONSIDERATIONS:

CONCLUSION

"FOR THE PEOPLE, BY THE PEOPLE" IS MORE THAN JUST A PHRASE; IT EMBODIES THE IDEAL OF A PARTICIPATORY, INCLUSIVE, AND ACCOUNTABLE DEMOCRACY.
