THE TRIAL AND EXECUTION OF CHARLES I

IN 1649, CHARLES I WAS PUT ON TRIAL FOR TREASON AGAINST THE REALM. THE COURT FOUND HIM GUILTY, AND ON JANUARY 30, 1649, HE WAS EXECUTED. THIS EVENT WAS REVOLUTIONARY—THE FIRST TIME A REIGNING MONARCH WAS LEGALLY TRIED AND EXECUTED BY HIS OWN PEOPLE.

WHERE WAS CHARLES I EXECUTED?

THE LOCATION OF THE EXECUTION

CHARLES I WAS EXECUTED AT WHITEHALL, A HISTORIC AREA IN CENTRAL LONDON. MORE SPECIFICALLY, THE EXECUTION TOOK PLACE OUTSIDE THE BANQUETING HOUSE, WHICH IS PART OF THE PALACE OF WHITEHALL COMPLEX.

THE SIGNIFICANCE OF WHITEHALL

WHITEHALL WAS THE ADMINISTRATIVE HEART OF THE ENGLISH GOVERNMENT AND THE ROYAL COURT DURING THAT PERIOD. THE DETAILS OF THE EXECUTION DAY

THE EVENTS LEADING UP TO THE EXECUTION

ON THE MORNING OF JANUARY 30, 1649, CHARLES I WAS TRANSPORTED FROM ST JAMES'S PALACE TO WHITEHALL. HIS JOURNEY WAS MARKED BY A MIXTURE OF SOLEMNITY AND RESOLVE. THE KING WAS ACCOMPANIED BY A SMALL ESCORT, AND CROWDS GATHERED TO WITNESS THE HISTORIC EVENT.

THE AFTERMATH AT WHITEHALL

FOLLOWING THE EXECUTION, THE AREA AROUND WHITEHALL BECAME A SYMBOL OF THE NEW REPUBLICAN ORDER. THE MONARCHY WAS ABOLISHED, AND ENGLAND WAS DECLARED A COMMONWEALTH UNDER OLIVER CROMWELL'S LEADERSHIP.

THE LOCATION'S HISTORICAL SIGNIFICANCE

WHITEHALL AS A POLITICAL CENTER

PRESERVATION AND MEMORIALS

TODAY, WHITEHALL REMAINS A HUB OF GOVERNMENT ACTIVITY, HOUSING SEVERAL GOVERNMENT DEPARTMENTS. A PLAQUE COMMEMORATES THE EXECUTION OF CHARLES I, SERVING AS A REMINDER OF THIS PIVOTAL MOMENT IN HISTORY.

OTHER NOTABLE SITES RELATED TO CHARLES I

THE BANQUETING HOUSE

THE BANQUETING HOUSE IS THE ONLY REMAINING PART OF THE PALACE OF WHITEHALL TODAY. IT IS A UNESCO WORLD HERITAGE SITE AND FEATURES STUNNING JACOBEOAN ARCHITECTURE. VISITORS CAN VIEW THE CEILING PAINTED BY PETER PAUL RUBENS, WHICH DEPICTS THE MARRIAGE OF JAMES I AND ANNE OF DENMARK.

ST. JAMES'S PALACE AND ST. JAMES'S PARK

THESE SITES ARE CLOSE TO WHITEHALL AND ARE HISTORICALLY CONNECTED TO THE ROYAL FAMILY. THEY OFFER CONTEXT TO THE ENVIRONMENT IN WHICH THE KING WAS TRIED AND EXECUTED.

THE LEGACY OF CHARLES I'S EXECUTION

IMPACT ON MONARCHY AND GOVERNANCE

THE EXECUTION SIGNIFICANTLY ALTERED THE RELATIONSHIP BETWEEN THE MONARCHY AND THE PEOPLE. IT LED TO A TEMPORARY ABOLITION OF THE MONARCHY AND THE ESTABLISHMENT OF A REPUBLICAN GOVERNMENT.

REINSTATEMENT OF THE MONARCHY

AFTER OLIVER CROMWELL'S DEATH AND THE SUBSEQUENT POLITICAL UPEHAVAL, THE MONARCHY WAS RESTORED IN 1660 WITH KING CHARLES II. NONETHELESS, THE EVENT OF CHARLES I'S EXECUTION REMAINED A DEFINING MOMENT IN BRITISH HISTORY.

The final part ties Harrison's political retreat to his initial emergence from obscurity; arguing that Harrison's relative political quietism during the later 1650s was a reflection of the development of his millenarianism. Unlike the only two previous full length studies of Harrison the present work makes use of a full range of manuscript, primary and secondary sources, including the huge range of new material that has fundamentally changed how the early modern period is now understood. Fully footnoted and referenced, this study provides the first modern academic study of Harrison, and through him illuminates the key themes of this contested period.
