COMPONENTS OF INTERQUAL LEVEL OF CARE CRITERIA

LEVELS OF CARE DEFINED

4. **INTENSIVE OR CRITICAL CARE:** THE HIGHEST LEVEL OF CARE, INVOLVING INTENSIVE MONITORING AND SPECIALIZED INTERVENTIONS, SUCH AS ICU OR CCU SETTINGS.

KEY CRITERIA ELEMENTS

APPLICATION OF INTERQUAL LEVEL OF CARE CRITERIA

IN THE HOSPITAL SETTING

HOSPITALS UTILIZE INTERQUAL CRITERIA PRIMARILY FOR DETERMINING:

- **ADMISSION DECISIONS:** IS THE PATIENT'S CONDITION SEVERE ENOUGH TO WARRANT INPATIENT CARE?
- **CONTINUED STAY:** DOES THE PATIENT STILL REQUIRE HOSPITAL-LEVEL CARE, OR CAN THEY TRANSITION TO A LOWER LEVEL?
- **DISCHARGE PLANNING:** WHEN IS THE APPROPRIATE TIME FOR THE PATIENT TO BE DISCHARGED OR TRANSFERRED?

THE PROCESS TYPICALLY INVOLVES CASE REVIEWS BY MULTIDISCIPLINARY TEAMS, INCLUDING PHYSICIANS, CASE MANAGERS, AND UTILIZATION REVIEW PERSONNEL, WHO ASSESS THE PATIENT'S CLINICAL DATA AGAINST INTERQUAL STANDARDS.

IN OUTPATIENT AND HOME CARE SETTINGS

FOR OUTPATIENT OR HOME HEALTH SERVICES, INTERQUAL CRITERIA HELP DETERMINE:

- IF OUTPATIENT MANAGEMENT IS SUFFICIENT

IN INSURANCE AND PAYER DECISIONS

INSURANCE COMPANIES AND PAYERS USE INTERQUAL CRITERIA DURING PRIOR AUTHORIZATION AND CONCURRENT REVIEW PROCESSES TO:

- AUTHORIZE HOSPITAL ADMISSIONS AND ONGOING STAYS
- APPROVE OR DENY COVERAGE FOR SPECIFIC SERVICES AND PROCEDURES
- ENSURE UTILIZATION IS ALIGNED WITH EVIDENCE-BASED STANDARDS

- SUPPORT DECISIONS FOR DISCHARGE PLANNING.
- IDENTIFY OPPORTUNITIES FOR STEP-DOWN OR LESS INTENSIVE CARE.

THIS PROCESS HELPS PREVENT UNNECESSARY HOSPITALIZATIONS, REDUCES READMISSION RATES, AND ENSURES OPTIMAL RESOURCE ALLOCATION.

CLINICAL DECISION SUPPORT
