WHAT IS A W2 FORM AND WHY IS IT IMPORTANT?

UNDERSTANDING THE W2 FORM

A W2 FORM, OFFICIALLY CALLED THE "WAGE AND TAX STATEMENT," IS A DOCUMENT ISSUED ANNUALLY BY EMPLOYERS TO THEIR EMPLOYEES. IT SUMMARIZES THE TOTAL WAGES EARNED AND TAXES WITHHELD DURING THE CALENDAR YEAR. THE INTERNAL REVENUE SERVICE (IRS) REQUIRES EMPLOYERS TO SEND COPIES OF THIS FORM TO BOTH THE EMPLOYEE AND THE IRS.

KEY COMPONENTS OF A W2 FORM INCLUDE:

- TOTAL WAGES, TIPS, AND OTHER COMPENSATION
- FEDERAL INCOME TAX WITHHELD
- SOCIAL SECURITY WAGES AND TAX WITHHELD
- MEDICARE WAGES AND TAX WITHHELD
- STATE AND LOCAL TAX INFORMATION (IF APPLICABLE)
- EMPLOYEE AND EMPLOYER IDENTIFICATION DETAILS

THE SIGNIFICANCE OF THE W2 FORM FOR TAX FILING

YOUR W2 FORM IS ESSENTIAL WHEN PREPARING YOUR FEDERAL AND STATE INCOME TAX RETURNS. IT ENSURES ACCURATE REPORTING OF INCOME AND TAXES PAID, WHICH CAN AFFECT YOUR REFUND OR AMOUNT OWED. FAILING TO INCLUDE CORRECT W2 INFORMATION CAN LEAD TO DELAYS, PENALTIES, OR AUDITS.

BYU W2 FORMS: SPECIFICS AND UNIQUE ASPECTS

HOW BYU PROVIDES W2 FORMS

BRIGHAM YOUNG UNIVERSITY FOLLOWS STANDARD PROCEDURES TO DISTRIBUTE W2 FORMS TO ITS EMPLOYEES. TYPICALLY, EMPLOYEES RECEIVE THEIR W2 FORMS VIA:

- MAIL: THE UNIVERSITY MAILS PAPER COPIES TO THE ADDRESS ON FILE, USUALLY BY THE END OF JANUARY.
- ONLINE ACCESS: EMPLOYEES CAN ACCESS ELECTRONIC COPIES THROUGH BYU'S EMPLOYEE PORTAL OR HR SYSTEMS, OFTEN

VIA PLATFORMS LIKE EMPLOYEE SELF-SERVICE OR WORKDAY.

ELIGIBILITY FOR BYU W2 FORMS

ALL EMPLOYEES WHO EARNED WAGES FROM BYU DURING THE TAX YEAR SHOULD RECEIVE A W2 FORM. THIS INCLUDES:

- FULL-TIME AND PART-TIME STAFF
- STUDENT EMPLOYEES
- TEMPORARY OR SEASONAL WORKERS
- CONTRACT OR ADJUNCT FACULTY PAID THROUGH BYU PAYROLL

EMPLOYEES WHO DID NOT EARN WAGES OR RECEIVED STIPENDS OUTSIDE PAYROLL MAY NOT RECEIVE A W2 BUT MIGHT RECEIVE A 1099 FORM INSTEAD.

HANDLING MULTIPLE W2 FORMS

IN CASES WHERE EMPLOYEES WORKED MULTIPLE POSITIONS OR HAD MULTIPLE ROLES WITHIN BYU, THEY MIGHT RECEIVE MULTIPLE W2 FORMS. IT'S IMPORTANT TO COMBINE THESE FORMS WHEN FILING TAXES TO REPORT TOTAL INCOME ACCURATELY.

How to Access Your BYU W2 Form

ONLINE ACCESS TO W2 FORMS

MOST BYU EMPLOYEES PREFER TO ACCESS THEIR W2 FORMS ELECTRONICALLY FOR CONVENIENCE AND SPEED. HERE'S HOW TO DO IT:

1. LOG INTO THE EMPLOYEE PORTAL: USE YOUR BYU NETID AND PASSWORD TO ACCESS THE UNIVERSITY'S HR PORTAL.
2. NAVIGATE TO TAX DOCUMENTS OR W2 SECTION: LOOK FOR A TAB OR LINK LABELED "TAX DOCUMENTS," "W2 FORMS," OR SIMILAR.
3. DOWNLOAD OR PRINT: ONCE LOCATED, YOU CAN VIEW, DOWNLOAD, OR PRINT YOUR W2 FORM FOR YOUR RECORDS.

NOTE: ENSURE YOUR CONTACT INFORMATION IS CURRENT TO RECEIVE NOTIFICATIONS ABOUT UPDATES OR AVAILABILITY.

REQUESTING A PAPER COPY

IF YOU PREFER OR REQUIRE A PAPER COPY:

- CONTACT BYU HUMAN RESOURCES OR PAYROLL DEPARTMENT.
- REQUEST A DUPLICATE W2 IF THE ORIGINAL WAS MISPLACED OR NOT RECEIVED.
- EXPECT TO VERIFY YOUR IDENTITY FOR SECURITY PURPOSES.

IMPORTANT DEADLINES

- W2 DISTRIBUTION DEADLINE: TYPICALLY BY JANUARY 31ST.

- ACCESS WINDOW: AVAILABLE THROUGHOUT THE TAX SEASON, GENERALLY UNTIL APRIL 15TH OR LATER DEPENDING ON EXTENSIONS.

INTERPRETING YOUR BYU W/2 FORM

- Box 3: SOCIAL SECURITY WAGES.
- Box 4: SOCIAL SECURITY TAX WITHHELD.
- Box 5: MEDICARE WAGES.
- Box 6: MEDICARE TAX WITHHELD.
- Box 16: STATE WAGES, TIPS, ETC. (IF APPLICABLE).
- Box 17: STATE INCOME TAX WITHHELD.

COMMON ISSUES AND HOW TO RESOLVE THEM

- INCORRECT PERSONAL INFORMATION: CONTACT HR FOR CORRECTION.
- MISMATCH BETWEEN W/2 AND PERSONAL RECORDS: VERIFY WAGES WITH YOUR PAY STUBS.
- MISSING W/2: CONTACT BYU HR OR PAYROLL IMMEDIATELY.
- LATE RECEIPT: CONFIRM MAILING ADDRESS OR ACCESS ONLINE.

WHAT TO DO IF YOU ENCOUNTER PROBLEMS WITH YOUR BYU W/2

INCORRECT W/2 INFORMATION

IF YOU FIND ERRORS SUCH AS WRONG WAGES, TAXES, OR PERSONAL DETAILS:

- CONTACT BYU HR OR PAYROLL PROMPTLY.
- REQUEST A CORRECTED W/2 (FORM W-2c).
- KEEP DOCUMENTATION OF COMMUNICATION FOR YOUR RECORDS.

MISSING W/2 FORM

IF YOU HAVEN'T RECEIVED YOUR W/2 BY MID-FEBRUARY:

- CHECK YOUR ONLINE PORTAL FIRST.
- CONFIRM YOUR MAILING ADDRESS.
- CONTACT HR OR PAYROLL TO REQUEST A DUPLICATE.

CHANGING YOUR CONTACT INFORMATION

ENSURE YOUR MAILING ADDRESS AND CONTACT DETAILS ARE CURRENT IN BYU RECORDS TO RECEIVE TIMELY DOCUMENTS. UPDATE THIS THROUGH THE EMPLOYEE PORTAL OR HR.

TAX FILING TIPS FOR BYU EMPLOYEES

- USE YOUR W2 TO ACCURATELY REPORT INCOME.
- CROSS-REFERENCE YOUR PAY STUBS AND W2 FOR CONSISTENCY.
- CONSIDER CONSULTING A TAX PROFESSIONAL IF YOU HAVE MULTIPLE INCOME SOURCES OR COMPLEX CIRCUMSTANCES.
- BE AWARE OF FEDERAL AND STATE DEADLINES TO AVOID PENALTIES.
- KEEP COPIES OF YOUR W2 AND RELATED DOCUMENTS FOR AT LEAST THREE YEARS.

IF YOU DIDN'T RECEIVE YOUR W-2 OR FIND ERRORS, CONTACT BYU'S HUMAN RESOURCES OR PAYROLL DEPARTMENT PROMPTLY TO REQUEST A COPY OR CORRECTIONS TO ENSURE ACCURATE TAX FILING.

CAN I GET A DUPLICATE BYU W-2 IF I LOSE THE ORIGINAL?

YES, YOU CAN REQUEST A DUPLICATE W-2 FORM THROUGH THE BYU EMPLOYEE SELF-SERVICE PORTAL OR BY CONTACTING THE PAYROLL DEPARTMENT DIRECTLY.

ARE BYU W-2 FORMS AFFECTED BY REMOTE WORK OR PAYROLL CHANGES?

REMOTE WORK OR PAYROLL ADJUSTMENTS GENERALLY DO NOT AFFECT THE DISTRIBUTION OF W-2 FORMS, BUT ANY CHANGES IN YOUR EMPLOYMENT STATUS SHOULD BE REFLECTED CORRECTLY ON YOUR W-2 FOR ACCURATE REPORTING.

HOW DOES BYU HANDLE W-2 FORMS FOR STUDENT EMPLOYEES OR INTERNS?

STUDENT EMPLOYEES AND INTERNS AT BYU RECEIVE W-2 FORMS JUST LIKE REGULAR EMPLOYEES, REFLECTING THEIR EARNINGS AND TAXES WITHHELD FOR THE YEAR, WHICH CAN BE ACCESSED VIA THE SAME PORTAL.
