THESE RATES TYPICALLY INCLUDE:

- BASE WAGES FOR SPECIFIC LABOR CATEGORIES
- OVERHEAD AND ADMINISTRATIVE COSTS
- PROFIT MARGINS
- INDIRECT COSTS

GSA LABOR RATES ARE USED TO STREAMLINE PROCUREMENT PROCESSES, ENSURE TRANSPARENCY, AND PROMOTE FAIR COMPETITION AMONG VENDORS.

- IT AND CYBERSECURITY
- ENGINEERING AND TECHNICAL
- FINANCIAL AND ACCOUNTING

EACH CATEGORY HAS DESIGNATED RATES THAT REFLECT THE TYPICAL WAGES AND ASSOCIATED COSTS FOR THOSE ROLES.

- DATA SCIENTISTS
- SOFTWARE DEVELOPERS
- COMPLIANCE AND RISK ANALYSTS

THESE ROLES OFTEN COMMAND PREMIUM RATES, WHICH ARE REFLECTED IN THE UPDATED GSA SCHEDULES.

HOW GSA LABOR RATES ARE DETERMINED

RATE CALCULATION PROCESS

THE PROCESS INVOLVES SEVERAL STEPS:

1. WAGE DETERMINATIONS: BASED ON PREVAILING WAGES IN SPECIFIC GEOGRAPHIC AREAS, OFTEN DERIVED FROM THE DEPARTMENT OF LABOR'S DAVIS-BACON ACT DETERMINATIONS.
2. COST ALLOCATION: OVERHEAD, ADMINISTRATIVE COSTS, AND INDIRECT COSTS ARE ADDED TO WAGES.

3. PROFIT MARGIN: A STANDARD PROFIT PERCENTAGE IS INCORPORATED.

4. FINAL RATE SETTING: THE SUM OF ALL COMPONENTS RESULTS IN THE PUBLISHED GSA LABOR RATE FOR EACH CATEGORY.

LABOR CATEGORY DEFINITIONS

GSA SCHEDULES TYPICALLY DEFINE LABOR CATEGORIES WITH DETAILED DESCRIPTIONS, SKILL REQUIREMENTS, AND EXPERIENCE LEVELS. EXAMPLES INCLUDE:

- PROGRAM MANAGER: OVERSEES PROJECT EXECUTION, CLIENT COMMUNICATION.
- SYSTEMS ENGINEER: DESIGNS AND MAINTAINS TECHNICAL SOLUTIONS.
- ADMINISTRATIVE SUPPORT: HANDLES DOCUMENTATION, SCHEDULING.
- CYBERSECURITY SPECIALIST: ENSURES SECURITY COMPLIANCE, THREAT MITIGATION.

EACH CATEGORY HAS ASSOCIATED RATES THAT REFLECT THE MARKET VALUE OF THOSE SKILLS IN 2023.

How GSA Labor Rates Are Calculated in 2023

THE CALCULATION PROCESS INVOLVES MULTIPLE STEPS TO ENSURE RATES ARE FAIR, COMPETITIVE, AND COMPLIANT.

STEP 1: DATA COLLECTION

CONTRACTORS GATHER DATA ON:

- CURRENT EMPLOYEE WAGES AND BENEFITS.
- INDIRECT COSTS FROM FINANCIAL STATEMENTS.
- MARKET SURVEYS AND INDUSTRY BENCHMARKS.
- REGULATORY GUIDELINES AND HISTORICAL DATA.

STEP 2: RATE DEVELOPMENT

USING THE COLLECTED DATA, CONTRACTORS DEVELOP RATES BY:

- ALLOCATING DIRECT WAGES TO SPECIFIC LABOR CATEGORIES.
- APPLYING OVERHEAD RATES BASED ON INDIRECT COST POOLS.
- ADDING G&A EXPENSES.

- INCORPORATING PROFIT MARGINS ALIGNED WITH INDUSTRY STANDARDS.

STEP 3: VALIDATION AND SUBMISSION

- THE RATES ARE COMPILED INTO A RATE PROPOSAL.
- GSA REVIEWS FOR REASONABLENESS, COMPLIANCE, AND FAIRNESS.
- ONCE APPROVED, THESE RATES ARE INCORPORATED INTO THE GSA SCHEDULE.

STEP 4: ANNUAL UPDATES

GIVEN ECONOMIC FLUCTUATIONS, CONTRACTORS TYPICALLY REVIEW AND UPDATE RATES ANNUALLY OR BI-ANNUALLY, REFLECTING CURRENT MARKET CONDITIONS.
