9. **SIGNATURE:** SIGN YOUR NAME AND INCLUDE CONTACT DETAILS.

THE PURPOSE OF THIS LETTER IS TO:

- EXPLAIN THE CIRCUMSTANCES THAT LED TO THE INADMISSIBILITY.
- DEMONSTRATE REMORSE, RESPONSIBILITY, AND REHABILITATION.
- PROVIDE EVIDENCE AND ARGUMENTS SUPPORTING THE CASE FOR FORGIVENESS.
- SHOW THE APPLICANT'S ELIGIBILITY FOR A WAIVER BASED ON SPECIFIC LEGAL CRITERIA.

5. REVIEW AND EDIT CAREFULLY

PROOFREAD FOR CLARITY, GRAMMAR, AND ACCURACY. CONSIDER HAVING AN IMMIGRATION ATTORNEY REVIEW YOUR LETTER TO ENSURE IT ALIGNS WITH LEGAL STANDARDS AND EFFECTIVELY COMMUNICATES YOUR CASE.
