- CLEARLY LIST THE CONTENTS OF YOUR SUBMISSION:
 - FORM I-751 COMPLETED AND SIGNED.
 - EVIDENCE PROVING YOUR MARRIAGE IS BONA FIDE.
 - JOINT DOCUMENTS (IF APPLICABLE).
 - PERSONAL AFFIDAVITS.
 - ANY ADDITIONAL DOCUMENTATION.

BE CLEAR AND CONCISE

ORGANIZE YOUR DOCUMENTS

- NUMBER OR BULLET YOUR DOCUMENTATION LIST FOR CLARITY.

PERSONALIZE YOUR LETTER

BEST PRACTICES FOR DRAFTING YOUR COVER LETTER

TO MAXIMIZE THE EFFECTIVENESS OF YOUR I-751 COVER LETTER, CONSIDER THE FOLLOWING BEST PRACTICES:

- BE CLEAR AND CONCISE: KEEP YOUR LANGUAGE STRAIGHTFORWARD, AVOIDING JARGON OR UNNECESSARY DETAILS.

- **USE FORMAL TONE:** MAINTAIN PROFESSIONALISM THROUGHOUT YOUR LETTER.
- **TAILOR CONTENT:** CUSTOMIZE THE LETTER TO REFLECT YOUR UNIQUE CIRCUMSTANCES, ESPECIALLY IF DIFFERENT FROM THE NORM.
