UNDERSTANDING THE TYPES OF COMMERCIAL DRIVER'S LICENSES IN TEXAS

THE TEXAS CDL HANDBOOK 2023 EXPLAINS THE DIFFERENT CLASSES OF LICENSES BASED ON THE VEHICLE TYPE AND PURPOSE. HERE'S A BREAKDOWN:

CLASS A CDL

THIS LICENSE ALLOWS YOU TO OPERATE A COMBINATION OF VEHICLES WITH A GROSS COMBINED VEHICLE WEIGHT RATING (GVW) OF 26,001 POUNDS OR MORE, PROVIDED THE TOWED VEHICLE EXCEEDS 10,000 POUNDS. COMMONLY USED FOR TRACTOR-TRAILERS, SEMI-TRUCKS, AND LARGE HAULING VEHICLES.

CLASS B CDL

PERMITS YOU TO DRIVE A SINGLE VEHICLE WITH A GVW OF 26,001 POUNDS OR MORE, OR A VEHICLE TOWING A VEHICLE UNDER 10,000 POUNDS. EXAMPLES INCLUDE BUSES, DUMP TRUCKS, AND DELIVERY TRUCKS.

CLASS C CDL

REQUIRED FOR OPERATING VEHICLES DESIGNED TO CARRY 16 OR MORE PASSENGERS (INCLUDING THE DRIVER), OR TRANSPORTING HAZARDOUS MATERIALS REQUIRING PLACARDING.

ENDORSEMENTS

SPECIFIC ENDORSEMENTS ADD QUALIFICATIONS TO YOUR LICENSE, SUCH AS:

- T – DOUBLE/TRIPLE TRAILERS

- P – PASSENGER TRANSPORT
- H – HAZARDOUS MATERIALS
- N – TANK VEHICLES
- X – HAZARDOUS MATERIALS COMBINED WITH TANK VEHICLE

ELIGIBILITY REQUIREMENTS FOR A TEXAS CDL IN 2023

BEFORE APPLYING, ENSURE YOU MEET THE FOLLOWING ELIGIBILITY CRITERIA OUTLINED IN THE TEXAS CDL HANDBOOK 2023:

AGE REQUIREMENTS

1. MINIMUM AGE OF 18 FOR INTRASTATE DRIVING (WITHIN TEXAS)
2. MINIMUM AGE OF 21 FOR INTERSTATE COMMERCE OR HAULING HAZARDOUS MATERIALS ACROSS STATE LINES

RESIDENCY AND LEGAL STATUS

- MUST BE A U.S. CITIZEN OR LEGAL RESIDENT OF TEXAS
- PROVIDE PROOF OF IDENTITY, RESIDENCY, AND LAWFUL PRESENCE

MEDICAL CERTIFICATION

- PASS A DEPARTMENT OF TRANSPORTATION (DOT) MEDICAL EXAM
- CARRY A MEDICAL EXAMINER'S CERTIFICATE (MEDICAL CARD) DURING DRIVING

DRIVING RECORD AND BACKGROUND CHECKS

- MUST NOT HAVE SERIOUS TRAFFIC VIOLATIONS OR DISQUALIFYING OFFENSES
- BACKGROUND CHECKS MAY BE REQUIRED FOR CERTAIN ENDORSEMENTS, ESPECIALLY HAZARDOUS MATERIALS

STEPS TO OBTAIN YOUR TEXAS CDL IN 2023

THE PROCESS INVOLVES SEVERAL STEPS, AS DETAILED IN THE [TEXAS CDL HANDBOOK 2023](#). HERE'S AN OVERVIEW:

1. STUDY THE HANDBOOK

- REVIEW THE ENTIRE MANUAL THOROUGHLY
- FOCUS ON THE SECTIONS RELEVANT TO YOUR LICENSE CLASS AND ENDORSEMENTS

2. OBTAIN A COMMERCIAL LEARNER'S PERMIT (CLP)

1. PASS THE WRITTEN KNOWLEDGE TEST(S) FOR YOUR LICENSE CLASS AND ENDORSEMENTS
2. SUBMIT NECESSARY DOCUMENTS AND PAY APPLICABLE FEES
3. COMPLETE THE MEDICAL EXAM AND OBTAIN CERTIFICATION

3. PRACTICE DRIVING WITH A CLP

- PRACTICE OPERATING COMMERCIAL VEHICLES UNDER SUPERVISION
- GAIN EXPERIENCE BEFORE SCHEDULING THE SKILLS TEST

4. SCHEDULE AND PASS THE SKILLS TEST

1. PRE-TRIP INSPECTION TEST
2. BASIC VEHICLE CONTROL SKILLS TEST
3. ON-ROAD DRIVING TEST

5. OBTAIN YOUR CDL

- PASS ALL REQUIRED TESTS
- PAY LICENSING FEES
- RECEIVE YOUR OFFICIAL TEXAS CDL

2. **PRACTICE WITH SAMPLE QUESTIONS:** USE PRACTICE TESTS TO FAMILIARIZE YOURSELF WITH THE EXAM FORMAT.
3. **ATTEND CDL TRAINING CLASSES:** CONSIDER ENROLLING IN A RECOGNIZED DRIVING SCHOOL FOR HANDS-ON TRAINING.
4. **LEARN VEHICLE INSPECTION PROCEDURES:** MASTER PRE-TRIP INSPECTION TO PASS THE SKILLS TEST CONFIDENTLY.
5. **STAY UPDATED ON REGULATIONS:** BE AWARE OF ANY CHANGES IN STATE OR FEDERAL LAWS AFFECTING COMMERCIAL DRIVING.
