6. TERMINATION CONDITIONS

DEFINE THE CONDITIONS UNDER WHICH THE AGREEMENT CAN BE TERMINATED. THIS MAY INCLUDE:

- NOTICE PERIOD REQUIRED FOR TERMINATION
- CONDITIONS FOR EARLY TERMINATION
- CONSEQUENCES OF BREACHING THE AGREEMENT

CREATING A FURNITURE RENTAL AGREEMENT TEMPLATE IN MICROSOFT WORD
